Short title 1. This Act may be cited as the Control of Dogs Act.

Interpretation 2. In this Act, unless the context otherwise requires -

"dog" includes a bitch;

"dog control officer" means a police officer, a Veterinary Officer, a health inspector in terms of section 2 of the

Cap. 189 Public Health Act, or an Inspector in terms of section 6 of

Cap. 9 the Animals (Diseases and Imports) Act;

"Licensing Authority" means the Licensing Authority

Cap. 113 established in section 3 of the Licences Act;

"special control area" has the meaning given in section 7;

"Veterinary Officer" includes the Chief Veterinary Officer.

Control of 3. Every owner of a dog or person in charge of a dog shall keep dogs the dog under control in such manner as may be prescribed.

Impounding 4.(1) A dog control officer may, in accordance with regulations,

of stray dogs seize a dog found unattended in any street, road, or other public place and impound it at any police station or at another place approved for the purposes of this sub-section by the Minister.

(2)A dog control officer who, under sub-section (1), seizes a dog wearing a disc or label issued by the Licencing Authority shall, within 24 hours of the seizure, give notice to the owner of the dog that it has been seized and impounded.

(3)The Chief Veterinary Officer shall cause every dog impounded under sub-section (1) to be taken from the police station or other place where it is first impounded to another place appointed as a stray dog pound by the Minister by order in the Gazette.

Release of 5. If within the period of 4 days commencing on the day the dog impounded is seized and impounded, its owner demands its release, the person dogs holding the dog under section 4 shall release it to the owner on his paying such charge as may be prescribed for each day or part of a day during which the dog has been impounded.

Destruction of 6.(1) If a dog has not been released to its owner in terms of impounded section 5, a Veterinary Officer may cause it to be destroyed.

(2)No person shall subject a dog seized or impounded under this Act to vivisection, or dispose of it for vivisection.

Special 7. The Minister may, by notice in the Gazette, declare any control area or island to be a special control area.

Poison baits 8.(1) In a special control area, the Chief Veterinary Officer or a in special person authorized in writing by him may lay or expose, on any public control areas place or private land, poisonous bait for the destruction of dogs.

(2)For the purposes of this section, the Chief Veterinary Officer or a person authorized in writing by him may enter any land or premises and may take with him such persons and things as he considers necessary for those purposes.

(2) Subject to sub-section (3), no compensation shall be payable to any person for any act done in good faith under this Act.
(3) Nothing in this section exempts the Government, any dog control officer, any public officer or any person authorized by the Chief Veterinary Officer from liability for any act done negligently under section 8
Offences and 11.(1) No person shall prevent, hinder or obstruct -
penalties
(a) a dog control officer; or
(b) the Chief Veterinary Officer or a person authorized in writing by him under section 8(1),
in the performance of his functions under this Act.
(2) A person who contravenes sub-section (1) or section 3 or 6(2) is guilty of an offence.
(3) A person guilty of an offence under this section is liable to imprisonment for 1 month and to a fine of $R.2,000$ .
