THE SIERRA LEONE ELECTRICITY AND WATER REGULATORY COMMISSION

(ACT NO 9 OF 2011)

Short title Certification (Professionals, Contractors, Manufacturers and Importers in the Water Supply Industry) Rules 2019

In exercise of the powers conferred upon it by Section 66 of the Sierra Leone Electricity and Water Regulatory Commission Act 2011, the Commission hereby makes the following rules-

PART I - PRELIMINARY

Interpretation 1. In these rules unless the context otherwise requires -

"Act" means the Sierra Leone Electricity and Water Regulatory Commission Act, 2011;

"artisan" means a plumber who qualified through an apprenticeship programme and has been so certified;

"associate engineer" means a person with the technical school certificate Level 4 of NCTVA certified for level 4 in construction or the equivalent in a relevant field;

"consultant" means an engineer or engineering company which has been certified to provide services relating to the design, engineering, procurement and construction or project supervision as well as inspection and testing;

"contractor" means an individual or company which has been certified to undertake plumbing contracting, including installation and maintenance;

"contracting company" means a plumbing entity which is registered with the related trades certification;

"Council" means the Sierra Leone Professional Engineers Registration Council established under section 3 of the Professional Engineers Acts 1990;

"pipeline works" means the laying of pipeline systems together with associated equipment and facilities;

"pipeline or plumbing professional" means an engineer of all classes or a technician of all grades or both that has a technical educational qualification of a degree, diploma or certificate in technical training;

"pipeline or plumbing activity" includes plumbing design, installation, maintenance, testing, inspection manufacture and import of various plumbing goods and material;

"plumbing works" means water installation activities within a premises;

"engineer" means a person with a Bachelor of Science degree or higher or the equivalent qualification in an approved course in plumbing, mechanical, chemical or civil engineering from a recognised university or equivalent institution and is a member of and duly registered in the Register of Professional Engineers of Sierra Leone by the Council;

"experience" means verifiable previous personal involvement in or practice of plumbing or other related activities:

"junior technician" means a person who has completed the Level 1 of NCTVA and successfully undergone at least six months of technical training from a recognised training center or a supervised mentorship or apprenticeship programme;

"material and equipment" means plumbing equipment, pipes and material;

NCTVA" means the National Council for Technical, Vocational and Other Academic Awards;

"senior technician" means a person with the technical school certificate Level 3 of NCTVA certified for level 3 in construction or the equivalent in a relevant field;

"technician" means a person with the technical school Level 2 of NCTVA certified for construction or the equivalent in a relevant field.

Application

2. These rules shall apply to professionals or

of rules

companies that undertake pipe laying and plumbing activities including the following –

- a) pipe line systems design;
- b) installation;
- c) maintenance;
- d) testing;
- e) inspection;
- f) contracting;
- g) consultancy; and
- h) importation of pipeline and plumbing material and equipment relating to the supply of potable water.

PART II – APPLICATION FOR CERTIFICATE AND OTHER RELATED PROVISIONS

Requirement for a certificate

3 No person shall undertake a pipeline laying or plumbing activity unless that person holds a certificate issued by the Commission for that purpose.

Multiple Certificate

4. An applicant who wishes to undertake more than one activity under these rules shall apply for a multiple certificate

Types of Certificate

5 The types of certificates to be issued by the Commission shall be as follows-

- a) the pipe layer and plumber's certificate;
- b) the pipeline contracting certificate;
- c) the manufacturer's certificate; and
- d) the importer's certificate.

Mode of Application

- 6 (1) A person who wishes to undertake any activity under these rules shall make a written application in the prescribed form to the Commission.
 - (2) A person applying for
 - a) a pipe layer and plumber's certificate shall fill out the form set out in Schedule 1A;
 - b) a pipeline contractor's certificate shall fill out the form set out in Schedule 1B

- c) a manufacturer's certificate shall fill out the form set out in Schedule 1C; and
- d) an importer's certificate shall fill out the form set out in Schedule 1D
- (3) An application for a certificate shall be accompanied with all the supporting documents relevant to the certificate applied for.
- (4) An application shall be signed by the applicant, addressed to the Commission and delivered by post or email.

Application Fees

7. The applicant shall submit the application with a non-refundable fee as to be determined by the Commission and Published in the Gazette.

Receipt of Application

8. The Commission shall within 10 days of receiving an application issue a letter to the applicant acknowledging receipt of the application.

Decision of Commission

9(1) The Commission shall within 30 days from the date of receiving the application make a decision and notify the applicant of the decision in writing.

- (2) A certificate shall be issued by the Commission unless the applicant fails to meet the technical, financial and managerial capability criteria under the Act or statutory instruments made pursuant to the Act.
- (3) If the Commission refuses the application, it shall in writing communicating the decision to the applicant stating the reasons for the refusal.

Annual Fees

- 10(1) The holder of a certificate shall pay the annual fee as determined by the Commission and published in the Gazette.
- (2) The annual fee shall be paid on or before each anniversary of the date of first issuance

Duration and Renewal of Certificate

- 11(1) A certificate shall be valid for a period of 3 years in the case of an individual and 5 years in the case of a body corporate subject to these rules.
- (2) Subject to these rules the certificate may be renewed by the Commission at the end of its term.

Suspension or cancellation

- 12(1) The Commission may suspend or cancel a certificate where it is satisfied that
 - a) the holder has
 - i) contravened a term or condition of the certificate;
 - ii) given information to the Commission which is false or misleading;
 - b) it is in the public interest to do so.
- (2) When the Commission has grounds for the cancellation of a certificate, it shall notify the holder to show cause why the certificate should not be cancelled.
- (3) If the holder of the certificate is unable to persuade the Commission or fails to respond to the notice, the Commission shall proceed to cancel the certificate in accordance with section 35 of the Act.
- (4) The Commission shall restore the certificate when the holder remedies the matter that gave rise to the suspension or cancellation.

PART III – CATEGORIZES AND CLASSES OF CERTIFICATE

Categories and classes

- 13(1) The Commission shall categorise pipeline and plumbing professionals into the following categories
 - a) engineer;
 - b) associate engineer;
 - c) senior technician;
 - d) technician;
 - e) junior technician; and
 - f) technician.
 - (2) The Commission shall further classify each category by education and experience as follows
 - a) Class A;
 - b) Class B
 - c) Class C
 - (3) The qualification for each class of pipeline and plumbing professional shall be as set out in Schedule 2.

Categories of contractors' certificate

- 14(1) The Commission shall categorise contractors in the following classes
 - a) Class 1
 - b) Class 2; and
 - c) Class 3
- (2) For purposes of certifying contractors, the following criteria shall apply:
 - a) work limits for each class of contractor;
 - b) the qualification and experience requirement for personnel;
 - c) the personnel, equipment and facilities requirement as set out in schedule 4;
 - d) evaluation methods for grading and upgrading as set out in schedule 3.

Work limits

- 15(1) A pipe layer or plumber may undertake activities of a lower class but shall not undertake activities that exceed the technical limits provided in this rule.
- (2) The technical limits for each class of a plumbing professional shall be as follows
 - a) Class A pipe layer or plumber shall have no technical limit;
 - b) Class B pipe layer shall be authorized to design, install and inspect distribution pipeline systems;
 - c) Class B plumber shall be authorized to design and perform plumbing works in respect of commercial and complex residential premises;
 - d) Class C pipe layer shall be authorized to perform plumbing works in house and bungalow type residential buildings and the laying of service pipelines.

PART IV - EVALUATION AND GRADING

Evaluation and grading

- 16 (1) The Commission may examine an applicant through a written examination, a performance test and if deemed necessary a practical test before a certificate is issued or upgraded.
- (2) The Commission shall develop a curriculum or appoint a professional entity to develop a curriculum for the

training, continuous education and examination of pipe layers and plumbers.

(3) The outline of the curriculum referred to in subrule (2) shall be based on the standards and rules relating to the water supply sector.

(4) The Commission shall -

- a) create a unit for Committee for works which shall be responsible for conducting the written examination or performance and practical tests;
- b) outsource the responsibility of conducting the written examination, performance and practical tests to an appropriate external professional or educational body.
- c) publish the examination schedule and the designated examination and performance testing centres in the Gazette and newspapers of mass circulation
- (5) The applicant shall be notified in writing of the result of the examination or test taken within 30 days
- (6) An applicant that is not successful in an examination or test conducted by the Commission may retake the written examination or performance and practical test after a six month period.
- (7) The Commission may on application waive the requirement for the written examination or performance and practical test in respect of any plumbing professional that has served a minimum number of 10 years with a governmental agency, a licenced public utility company or other relevant organisation.

Guidelines

17. The Commission may issue -

- a) guidelines on procedures for conducting the written examinations or performance and practical tests;
- b) criteria for waiving the written examination or performance and practical test.

Obligations of a manufacturer and importer

- 18. The holder of a manufacturer or importers' certificate shall ensure that -
 - (a) the material or equipment manufactured or imported meets the Sierra Leone or approved international standard; and
 - (b) an adequate requirement of qualified personnel and facilities are employed in their business.

Annual report

- 19(1) A holder of a certificate shall submit an annual report to the Commission on its activities for each operational calendar year.
- (2) The report shall be submitted before the end of the first quarter of the following year.

Register

- 20 (1) The Commission shall maintain a register of holders of certificates and the type of services they are qualified to perform.
- (2) The Commission shall publish the list of holders of certificates in the Gazette and on its website.

PART V – MISCELLANEOUS

Offences

- 21. A person who-
 - a) undertakes pipe laying or plumbing works, manufactures or sells pipes or plumbing materials and equipment without the requisite qualification and certification;
 - b) employs or permits to be employed persons without the requisite qualification or certification;
 - c) obstructs or interferes with a member of the Commission, officer or person employed by the Commission in the exercise of powers conferred by the Act and statutory instruments made under the Act;

commits an offence punishable under section 65 of the Act .

Transitional 22. A person prior to the coming into effect of these rules who was engaged in an activity requiring a certificate under these rules shall apply for the relevant certificate within 3 months of the coming into effect of these rules.

 - d. annual reports for preceding two years including a financial statement and a summary of plumbing industry activities undertaken during the period;
 - e. list of sub-contractors, if any;
 - f. evidence of insurance cover for personnel, equipment and facilities.
- (2) The applicant shall provide
 - a. a summary of plumbing work experience, if any;
 - b. written references from a minimum of four clients confirming the plumbing or electromechanical works undertaken;
- (3) Where the plumbing consulting or contracting company has been in existence for less than two years, the Commission may rely on the individual experience of the key professional staff in lieu of the corporate experience of the company and the written references from the clients of such employees or a former employer.

- (2) In the case of an application relating to a manufacturer's certificate, the applicant shall in addition provide the relevant Environmental and Social Impact Assessment.

- 6. Availability of relevant applicable laws, regulations, codes, technical manuals, procedural manuals
- 7. Testing and measurement equipment
- 8. Insurance policy

Part 2: Criteria for Grading and Upgrading Contractors

- 1. Financial soundness from bank statement or Working Capital availability such as overdraft facility from bank and fixed deposits receipts with banks
- 2. Value of assets
- 3. Track record and evidence of works
- 4. Financial capability from tax clearance, equity, liability and credit statements and guarantee
- 5. Insurance guarantee
