FISHERIES MANAGEMENT (AMENDMENT) REGULATIONS 2019

IN exercise of the powers conferred by section 129 of the *Fisheries and Management Act 2015*, the Minister of Fisheries and Marine Resources makes the following Regulations:

1 Citation

These Regulations may be cited as the *Fisheries Management (Amendment) Regulations 2019*.

2 Commencement

These Regulations commence on the date of publication in the Gazette.

3 Amendment to regulation 70(1)

Regulation 70(1) of the principal regulations is amended by repealing Sub-regulation (v) and substituting the following:

“(v) LN94/2013; and”.
