

Somali legislation

Law No. 34 of 1 March 1971 - Establishment National Parks Agency

Art. 1 para 1 - The National Parks Agency is established under the supervision of the President of the Supreme Revolutionary Council.

Para 2 - the Agency is "autonomous body with juridical personality and shall be subject to the provisions of"

Law No. 16 of 1 April 1970 -

Paragraph 3 - The Agency's Headquarters are Mogadiscio and it may open branches anywhere in the Republic.

Art. 2 - The President may give directions to the Agency.

Art. 3 - "Main objective of the Agency shall be to establish and maintain national parks and reserved areas."

Art. 4 - The Agency shall have all powers necessary in particular the power to charge fees.

Art. 5 para 1 - There shall be a General Manager.

" para 2 - The General Manager is appointed by Decree of the Supreme Revolutionary Council.

Art. 6 para 1 - The General Manager is Executive Head of the Agency.

" para 2 - The General Manager may conclude contracts.

" para 3 - The General Manager is responsible for finance.

" para 4 - In the absence of the General Manager, the President of the Supreme Revolutionary Council designates the substitute

Art. 7 para 1 - "The Agency may appoint the staff required by it."

para 2 - Terms of employment are governed by regulations of the agency, subject to the general personnel rules applicable to autonomous agencies.

Art. 8 "The General Manager and the staff of the Agency shall, while performing their duties, be deemed to be officers of the civil services for purposes of responsibility."

Art. 9 - "The capital of the Agency shall consist of: (a) contributions made by the state public bodies, international organizations and private persons;" Fees; other receipts.

Art. 10 - The General Manager submits a budget to the Presidency and the Minister of Finance.

Art. 11 para 1 - Accounts are submitted to the Presidency and the Minister of Finance.

para 2 - The accounts are approved by the Presidency in consultation with the Minister of Finance.

Art. 12 - "The Agency shall, for the purposes of its activity, obtain loans from financial institutions with the Republic and abroad, with the prior approval of the President of the Supreme Revolutionary Council."

Art. 13 - Accounts are to be prepared as "prescribed by any general rules issued by the Government for the purpose and by the regulations of the Agency."

Art. 14 . The Accounts are audited by the Autonomous Agencies/<sup>Unit</sup>in the Office of the Magistrate of Accounts.

Art. 15 - "The regulations of the Agency shall be issued by Decree of the President of the Supreme Revolutionary Council."

Art.16 - All contrary laws are repealed.

Art. 17 para 2 - "This law shall be deemed to have come into force on 13.8.1970."
