## REGULATION

## ON STATE INSPECTION ON QUARANTINE OF PLANTS AT MINISTRY OF AGRICULTURE OF THE REPUBLIC OF TAJIKSTAN (TAJIKGOSQUARANTINE)

1. The State Inspection on Quarantine of Plants at Ministry of Agriculture of the Republic of Tajikistan (Tajikgosquarantine) is a republican body of state management and in the activity Tajikistan submits to Ministry of Agriculture of the Republic of Tajikistan.

Tajikgosquarantine carries out according to the current legislation sector management in the field of protection of the territory of the Republic of Tajikistan from penetration from other states of quarantine and other dangerous wreckers, illnesses of plants and weeds, as well as duly revealing, localization and liquidation of them in republic.

Tajikgosquarantine of Tajikistan bears responsibility for realization of the decrees of Ministry of Agriculture of the Republic of Tajikistan in the field of realization of the state control over observance of established rules and measures on quarantine of plants by manufacture, preparation, transportation, storage, processing, realization and use of agricultural and other production of vegetative origin.

2. The basic tasks of Tajikgosquarantine are:

Elaboration of regulations, rules and instructions, activity in the field of external and internal quarantine of plants, regulated on the territory of the Republic of Tajikistan;

Study the structure of species and bio-ecology of absent and locally extended on the territory of the Republic of Tajikistan wreckers, illnesses of plants and weeds, and on its basis to elaborate the list of quarantine wreckers, illnesses of plants and weeds, in relation to which the state measures on quarantine of plants are established and carried out;

Elaboration of conditions of import of vegetative production from other states and other materials, conditions of transportation of such production in the republic from zones announced to be under quarantine as well as conditions of its use on the territory of the Republic of Tajikistan;

Elaboration of methods of quarantine examination, laboratory examination, diagnostics of latent infection and disinfecting of production of vegetative origin and other materials;

Realization of quarantine examination and laboratory examination of production of vegetative origin and other materials

imported to the Republic of Tajikistan from other states, including vegetative investments coming in luggage, items of mail and in hand luggage of the passengers, as well as vehicles arriving to the Republic of Tajikistan from other states;

Organization of improvement and quarantine disinfecting of production of vegetative origin and other materials, as well as vehicles arriving from other states and from zones of the republic, announced to be under quarantine;

Realization of quarantine examination of production of vegetative origin and other materials dispatched for export;

Realization of control inspections agricultural and others area, places of storage and processing of production of vegetative origin with the purpose of duly revealing of quarantine wreckers, illnesses of plants and weeds:

Establishment quarantine division of districts and micro districts on territory of the Republic of Tajikistan;

Elaboration together with scientific research institutions of effective measures on struggle with quarantine wreckers, illnesses of plants and weeds;

Wide introduction of achievement of science and advanced experience, as well as acquainting the population with measures on struggle with quarantine wreckers, illnesses of plants and weeds;

Realization of the state control over execution of quarantine measures by ministries, departments, establishments, enterprises and organizations, as well as separate persons;

The control on activity of quarantine nurseries, grading plots and greenhouses which are carrying out check of the quarantine condition of seeds and plants, delivered into the Republic of Tajikistan from other states, as well as from zones announced to be under quarantine on the territory of the republic;

Supervision on crops and plantings in nurseries, scientific research institutions, seeds-growing and flower-decorative economies with the purposes of maintenance of issue of a seeds and planting material, free from quarantine wreckers, illnesses of plants and weeds;

The control of realization of measures following from the international conventions and the agreements in the field of quarantine of plants concluded by the Republic of Tajikistan with other states.

## 3. Tajikgosquarantine has the right:

To enter freely at any time on the territory of river ports and piers, civil airports, railway stations, post offices, elevators, warehouses, in goods and passenger carriages, into civil planes, on fields of collective farms, state farms, experience and scientific research organizations, parttime farms, personal plots, in nurseries, gardens and vineyard greenhouses and other economies of various organizations and separate persons, as well as on the enterprises engaged in preparation, processing and realization of production of vegetative origin;

To receive from administration of customs houses, river ports and piers, civil airports, railway stations and other enterprises and organizations the information about staying, stored and sent production of vegetative origin, to require the appropriate documents concerning this production, to forbid an unloading of the cargoes, infected by wreckers, (acceptance and transportation of under quarantine materials without the quarantine documents are categorically prohibited);

To select samples of seeds of plants and other production for examination and subsequent laboratory examinations;

To carry out measures in places of detection of quarantine objects, as well as restrictions on export and use of production before execution of necessary quarantine measures in the places of detection of quarantine.

- 4. To establish, the frames of the fumigation detachment is financed at the expense of special means formed from receipts for works on disinfecting of production of vegetative origin, other under quarantine materials and vehicles.
- 5. The instructions Tajikgosquarantine within the limits of the functions, assigned to it and rights, given to it are obligatory for all institutions, enterprises, organizations and separate persons engaged in manufacture, preparations, storage, processing and transportation of the production of vegetative origin.
- 6. The State Inspection on Quarantine of Plants at Ministry of Agriculture of the Republic of Tajikistan is headed by the Chief.

Ministry of Agriculture of the Republic of Tajikistan nominates the Chief of State Inspection on Quarantine of Plants.

The Chief of State Inspection on Quarantine of Plants at Ministry of Agriculture of the Republic of Tajikistan is simultaneously Main State Inspector on Quarantine of Plants of the Republic of Tajikistan.

The Deputy Chief of Tajikgosquarantine is Deputy Main State Inspector on Quarantine of Plants of the Republic of Tajikistan.

The Chief of State Inspection on Quarantine of Plants in area or independent area - is simultaneously Main State Inspector on Quarantine of Plants according to area, or independent area.

8. A regulation about Tajikgosquarantine, Charter of the State Service on Quarantine of Plants of the Republic of Tajikistan are affirmed by Soviet of Ministers of the Republic of Tajikistan, and structure, number and fund of payment of work of the workers of the central device of Tajikgosquarantine are affirmed by Ministry of Agriculture of the Republic of Tajikistan.

The right of modification into the structure of the central device is given to the Chief of Tajikgosquarantine within the limits of the established number and fund of payment of work.

- 9. A list of staff and estimate of the charges of the central device of Tajikgosquarantine within the limits of number and fund of payment of work, as well as regulation about its structural divisions are affirmed by the Chief of Tajikgosquarantine.
- 10. Tajikgosqarantine has a seal with the image of the State Emblem of the Republic of Tajikistan and with its name.
