THE WATER SUPPLY AND SANITATION SERVICES (LICENCING FEES) RULES, 2015

Citation

1. These Rules may be cited as the EWURA Water Supply and Sanitation Services (Licensing Fees) Rules, 2015.

Application

2. These Rules shall apply to all Water Supply and Sanitation Authorities except DAWASA designated areas.

Water Supply and Sanitation Services Licensing Fess

- 2. These Rules provide for fees payable for:
 - (a) licence fees for Water Supply and Sanitation Authority;
 - (b) licence fees for a Bulk Water Supply and Sanitation Authority;
 - (c) application for a licence; and
 - (d) change of name of a licence.
- 3. Licencees operating prior to these Rules shall within 60 days upon coming into force of these Rules pay the required licence fee.
- 4. Licence fees are as specified in the Schedules.
