**THE MINING (MINERAL RIGHTS) (REVOCATION OF THE FIRST SCHEDULE)
 REGULATIONS, 2018**

- Citation 1. These Regulations may be cited as the Mining (Mineral Rights) (Revocation of the First Schedule) Regulations, 2018.
