THE SHINYANGA MUNICIPAL COUNCIL (ESTABLISHMENT AND
MAINTENANCE OF WATER SOURCES AND ENVIRONMENTAL SANITATION)
(AMENDMENTS) BY-LAWS, 2001

1. These By-laws may be cited as the Shinyanga Municipal Council

Sanitation) (Amendments) By-laws 2001, and shall be read as one with the Shinyanga Town Council (Establishment and Maintenance of Water Sources and Environment Sanitation) By-laws 1999 herein after referred to as the Principal By-laws.

Date of Operation 2. These By-laws shall come into operation on the date of publication in the *Government Gazette*.

Amendment of By-law 3 3. By-law 3 of the principal By-law is amended by deleting the whole By-law and substituting for it the following definitions:

"Council" means the Shinyanga Municipal Council;

"Mtaa" means a part or division of a ward and includes a part or a division of township situated within an area under individuals of an urban authority;

"Source of water" means a source of an improved well;

"Special Register" means a book containing records of registered water user group which are protected under these By-laws;

"Village" means in relation to Village the Village of that Village where water facilities are allocated;

"Village council" means the Village Council of the Village where water facilities are allocated;

"Water facility" means an improved well fitted with a pump;

"Water User Group (WUG)" means a group of individuals or Household at the Village or Mtaa level whose membership is open and are voluntarily united to establish and develop the source of water and maintain environmental sanitation and it shall be mandatory under these By-laws for every communal source of water established within the jurisdiction of the Council to be registered in the register of the Council. Recognized Public Institution or Social Economic Development Group with Legal Registration can as well establish and develop sources of water and shall be registered by the Council as a water user group in order to attain legal protection under these By-laws.

4. By-law 6 of the Principal By-laws is amended:

(i) by adding immediately after the word Village Council appearing in the first line of the By-law the word "Mtaa committee"

(ii) by deleting the word "District Council" appearing in the second line of the proviso and substituting for it the words "Municipal Council"

5. By-law 5 of the Principal by-law is hereby amended by deleting the whole section and substituting for it the following new By-law:

5.-(1) Members of water user groups shall have responsibility and obligations to protect their assets and water facility from theft or damage.

(2) If the pump or pump equipment components are stolen or damaged, the members of the water user group concerned shall have full responsibility and obligation to replace the stolen or damaged pump equipment/components within three months after theft or damage.

(3) Where members of the water user group whose pump or pump equipment are stolen or damaged, fail to replace within the prescribed period, it shall be lawful for the Municipal Director upon a resolution of the Council in that behalf to issue warrant in the form set out in schedule "B" (to the Court Broker requiring him to distain upon the personal goods and chattels of such members of the water user group to the value of such sum in order to replace a stolen or damaged pump or pump equipment/component.

Provided that such warrant shall not be issued unless the period of three months referred to in sub By-law (2) have expired.

6. By-law 8 of the Principal by-law is hereby amended by deleting the whole section and substituting for it the following By-law:

8. Any person who shall create nuisance or chaos at the source of water by disturbing members of water user group or any person who is entitled to collect water commits an offence.

7. By-law 9 of the Principal By-laws is hereby amended by deleting the whole by-law and substituting for it the following new by-law:

Construction of pit latrine or refuse facility or sources of water 9-(1). Any person who shall construct a pit latrine or hole for the reception of night foul, urine, dirty water or rubbish of any description within thirty metres from the source of water shall be guilty of an offence and shall be liable on conviction to a fine of ten thousand shillings and shall be compelled to de-struct or burry the hole or pit latrine constructed.

(2) Any Water User Group or Public Institution or Social Economic Group or Individual person who shall construct a Source of water within thirty metres from a constructed pit latrine or hole used for reception of night foul, urine, dirty water or rubbish of any description commits an offence under these By-laws and shall be compelled forthwith to destruct and or burry the well so constructed.

8. By-law 10 of the Principal By-laws is hereby amended by deleting the whole section and substituting for it the following new section:

Wash of clothes, body or grain 10. Any person who shall wash clothes of any kind of grain or urinate or allow animals to drink in a domestic water supply source or sources of water commits an offence.

9. By-law 11 of the Principal By-laws is hereby amended by deleting the section and substituting for it the following new By-laws:

matters 11. Any person who shall throw foul matter or thing or deposit or cause to be deposited noxious matter or throw dirty water or allow any foul or thing or dirty water to flow into or upon any water supply sources or source of water commits an offence.

10. By-law 12 of the Principal By-laws is hereby amended:

matters 12-(1) By adding immediately after the word "Ward Executive Officer" appearing in the first line of the by-law the word "Division Secretary".

(2) By adding immediately after the word "Country" appearing in the sixth line of the section the following words "and shall have powers under these By-laws to take legal action including taking to court anybody or member of the water user group who shall contravene any provision of these By-laws.

11. By-law 13 of the Principal By-laws is hereby amended by deleting the whole section and substituting for it the following new By-law:

13. Any person who shall destroy or steal or tamper with a pump or any part of the instrument from the source of water is guilty of an offence and upon conviction shall be liable to a fine exceeding Tshs. 10,000/= or an imprisonment for a term not exceeding five months or to pay back forthwith the destroyed or stole or tempered pump or part of instrument at the current price.

12. By-law 14 of the Principal By-laws is hereby amended by deleting the words "Shs. 5,000/= appearing in the third line of the section and substituting for it the words "Shs. 10,000/=
