- "Misitu" maana yake ni eneo la mkusanyiko wa nyasi au miti iliyopandwa au iliyoota yenyewe.
- "Mazao ya misitu" maana yake ni nyasi, mbao, nguzo, boriti, fito, kuni, mkaa, kamba, au kitu kingine chochote kinachotokana na miti au nyasi.

THE LOCAL GOVERNMENT (DISTRICT AUTHORITIES) ACT

(No. 7 of 1982)

BY-LAWS

Made under section 148

THE KIBONDO DISTRICT COUNCIL (CULTIVATION OF AGRICULTURAL LAND) BY-LAWS 1994

- 1. These By-laws, may be cited as the Kibondo District Council (Cultivation of Agricultural Land) By-laws, 1994.
 - 2. In these By-laws:
- "Authorized Officer" means the Officer appointed by the Council for the purpose of the By-laws.
- "Council" means the Kibondo District Council.
- "Food crops" means maize, paddy, cassava, beans, millet and bananas.
- "Insect or plant pest" means any insect or pest which is harmful for growing and vegetation crops or which may be harmful to sorrounding crops.
- "Resident" means any person who has habitually resident in the area of jurisdiction of the Council for a period of not less than a year but does not include any person:
 - (a) Who is under eighteen years of age.
 - (b) Who is incapable of working due to illness, old age, or infirmity.
 - (c) Who is engaged in full-time remunerative accupation.

G.N. No. 280 (contd.)

3. Every resident who holds land in accordance with local customary law relating to land tenure shall, unless otherwise directed in writing by an authorized officer, cultivate and maintain an area of not less than three acres out of which two acres shall be planted with cash crops and the other acre shall be planted with food crops.

Resident Responsibility

- 4. Any direction given by the Council shall be published in the area affected there-by in such manner as the authorized officer may deem fit.
- 5.—(1) Any resident who holds land in accordance with section 3 of the By-laws shall be obliged to cultivate or plant his land in accordance with the principles of good plant husbandry as shall be directed by the authorized officer for the purpose of maintaining and improving productivity.
- (2) Every resident who has cultivated any area under the provisions of these By-laws on which there are growing crops shall keep such area clean and free from weeds.
- (3) Any resident who has planted or cultivated any cash crops or crops and any food crops on his agricultural land and finds such cash crops or crop and such food crops or crops are affected with insect, plant pest or disease shall promptly report such infection to the authorized officer and shall comply with such instruction as may be given by such officer for the destruction of the insect, plant pest or disease and the prevention of its spread.
- 6. Subject to the provision of these By-laws no resident shall fell or uproot or cause to be felled or uprooted any cash crop or food crops or crops cultivated and maintained under the provisions of these By-laws for any purpose other that the purpose of agricultural improvement for the enhancement of the environment.
- 7. Any authorized officer may at all reasonable times enter upon any agricultural land for the purpose of inspection and for ensuring compliance with the provisions of these By-laws.
- 8. Any resident who contravenes or fails to comply with the provisions of these By-laws shall be guilty of an offence and shall be liable on conviction to a fine not exceeding five thousand shillings or to imprisonment for a term not exceeding six months or to both such fine and imprisonment.
