Weed Management Regulations 2017

I, the Governor in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, acting with the advice of the Executive Council, make the following regulations under the Weed Management Act 1999 .

1. Short title

These regulations may be cited as the Weed Management Regulations 2017 .

2. Commencement

These regulations take effect on the day on which their making is notified in the *Gazette*.

3. Interpretation

In these regulations –

Act means the Weed Management Act 1999 .

4. Infringement notice offences and penalties

For the purposes of section 61 of the Act –

- (a) an offence against a provision of the Act specified in Column 2 of the table in Schedule 1 is prescribed as an offence in respect of which an infringement notice may be served; and
- (b) the penalties specified in Column 3 of that table are the penalties applicable to those prescribed offences.

5. Legislation rescinded

The legislation specified in Schedule 2 is rescinded.
