Notification of the Ministry of Public Health

(No. 151) B.E. 2536 (1993)

Re: Prescribed prohibited substances used in food

It deems appropriate to amend the notification of the Ministry of Public Health,
Re: Prohibited substances in food.

By the virtue of provisions of Section 5 and 6(5) of the Food Act B.E. 2522 (1979),
the Minister of Public Health hereby issues the notification as follows:

Clause 1. The following Notifications shall be repealed:

1.1 Notification of Ministry of Public Health No. 4 (B.E. 2522) (1979)
Re: Prescribed prohibited substances used in food; dated 24th August B.E.2522 (1979);

1.2 Notification of Ministry of Public Health No. 93 (B.E. 2528) (1985)
Re: Prescribed prohibited substances used in food (No. 2); dated 25th July B.E.2528 (1985);

1.3 Notification of Ministry of Public Health No.106 (B.E. 2530) (1987)
Re: Prescribed prohibited substances used in food (No. 3); dated 24th April B.E.2530 (1987);

1.4 Notification of Ministry of Public Health No. 123 (B.E. 2532) (1989)
Re: Prescribed prohibited substances used in food (No. 4); dated 15th June B.E.2532 (1989);

Clause 2. The following substances are prohibited to use in food

2.1 Brominated vegetable oil

2.2 Salicylic acid

2.3 Boric acid

2.4 Borax

2.5 Calcium iodate or Potassium iodate except for use to improve
nutritional condition concerning iodine deficiency in accordance with an approval from the
Food and Drug Administration

2.6 Nitrofurazone

2.7 Potassium chlorate

2.8 Formaldehyde, Formaldehyde solution and Paraformaldehyde

2.9 Coumarin or 1,2-Benzopyrone or 5,6-Benzo- α -Pyronone) or cis-o-
coumaric acid anhydride or o-Hydroxycinnamic acid,lactone

2.10 Dihydrocoumarin or Benzo-dihydropyrene or 3,4 -Dihydrocoumarin
or Hydrocoumarin

2.11 Methyl alcohol or Methanol

2.12 Diethylene glycol or Dihydroxydiethyl ether or diglycol or 2,2'-Oxybis-ethanol or 2,2'-oxydiethanol

This notification shall come into force as from the day following date of its publication in the Government Gazette.
