CHAPTER 57:02

STATE GRANTS AND LEASES (RE-ISSUE) ACT

An Act relating to grants and leases of State land which have 1950 Ed. Ch. 27. No. 6. been lost or destroyed. 20 of 1904.

[17th November 1904]

1. This Act may be cited as the State Grants and Leases Short title. (Re-issue) Act.

2. (1) Whenever it appears to the satisfaction of the President Certificate of that any grant of land alienated in fee from the State before the loss or destruction. 9th August 1889, or any lease of State lands, has been destroyed or lost, the President may certify to the issue of such grant or lease.

(2) Such certificate shall state the date on which the grant or lease of State lands was issued, the name of the person to whom issued, the description of the parcel of land, and the nature and extent of the estate or interest granted or leased, and may be in the form set out in the Schedule.

(3) Every such certificate shall be signed by the President and shall be under the Public Seal of Trinidad and Tobago and shall be registered in the office of the Registrar General.

(4) Every such certificate shall, when registered, be admissible in evidence in all Courts of Justice, to the same extent and for the same purposes as the original grant or lease would have been admissible.

3. (1) Any person applying for a certificate under section 2 Proof of interest. shall, in addition to the proof of the destruction or loss of such grant or lease, furnish proof of his interest therein.

(2) The President may require the lands in respect of Survey and which a certificate is applied for to be surveyed, and the application for such certificate to be advertised in the Gazette and in such other newspaper as he may direct, and the cost of such survey and advertisement shall be paid by the applicant.
