EXPLANATORY NOTE

(This note is not part of the Regulations)

Mae'r Rheoliadau hyn, sy'n gymwys o ran Cymru, yn pennu ffioedd sy'n daladwy i Weinidogion Cymru ym maes iechyd planhigion. Maent yn dirymu ac yn disodli Rheoliadau Iechyd Planhigion (Ffioedd) (Cymru) 2013 (O.S. 2013/1700 (Cy. 164)) ("Rheoliadau 2013") (rheoliad 9).

These Regulations, which apply in relation to Wales, specify fees payable to the Welsh Ministers in the field of plant health. They revoke and replace the Plant Health (Fees) (Wales) Regulations 2013 (S.I. 2013/1700 (W. 164)) ("the 2013 Regulations") (regulation 9).

Mae'r ffioedd yn daladwy mewn perthynas ag arolygiadau penodedig a gweithrediadau eraill a gyflawnir yn unol â Chyfarwyddeb y Cyngor 2000/29/EC ar fesurau i amddiffyn rhag dwyn i mewn i'r Gymuned organebau sy'n niweidiol i blanhigion neu gynhyrchion planhigion, a rhag i'r organebau hynny ymledu o fewn y Gymuned (OJ Rhif L 169, 10.7.2000, t. 1).

The fees are payable in relation to specified inspections and other operations carried out pursuant to Council Directive 2000/29/EC on protective measures against the introduction into the Community of organisms harmful to plants or plant products and against their spread within the Community (OJ No L 169, 10.7.2000, p. 1).

Pennir y ffioedd am wiriadau dogfennol, gwiriadau adnabod a gwiriadau iechyd planhigion mewn perthynas â mewnfurion penodol o blanhigion, cynhyrchion planhigion a gwrthrychau eraill o drydydd gwledydd (rheoliad 2 ac Atodlenni 1, 2 a 3) yn unol â'r gofyniad yn Erthygl 13d o Gyfarwyddeb y Cyngor 2000/29/EC.

The fees for documentary, identity and plant health checks in relation to certain imports of plants, plant products and other objects from third countries (regulation 2 and Schedules 1, 2 and 3) are specified pursuant to the requirement in Article 13d of Council Directive 2000/29/EC.

Lefelau'r ffioedd y darperir ar eu cyfer yn y Rheoliadau hyn yw'r rhan olaf o symudiad fesul cam, dros gyfnod o dair blynedd, tuag at ffioedd sy'n adennill y gost lawn. Mae'r Rheoliadau hyn yn darparu ar gyfer gostyngiad a chynnydd cyfartalog ar y ffioedd a bennwyd yn Rheoliadau 2013, ac ar gyfer eu cadw heb eu newid, fel a ganlyn:

The fee levels provided for in these Regulations form the final part of a phased move towards full cost recovery of fees over a period of three years. These Regulations provide for average decreases and increases in, and the continuation unchanged of, the fees specified in the 2013 Regulations as follows:

(1) gostwng ffioedd arolygu mewnfurio (heblaw gwiriad dogfennol a gwiriad adnabod) yn ôl 3.5% (rheoliad 2 ac Atodlenni 1 a 2);

(1) import inspection fees (other than documentary and identity checks) decrease by 3.5% (regulation 2 and Schedules 1 and 2);

(2) cynyddu ffioedd gwiriad dogfennol a gwiriad adnabod wrth fewnforio yn ôl 24.5% (rheoliad 2 ac Atodlen 3);

(3) cadw ffioedd ynglŷn ag arolygu tatws hadyd heb eu newid (rheoliad 3 ac Atodlen 4);

(4) cynyddu ffioedd trwyddedu yn ôl 2.2% (rheoliad 4 ac Atodlen 5);

(5) cynyddu ffioedd am wasanaethau pasbortau planhigion yn ôl 21.2% (rheoliad 5); a

(6) cadw ffioedd am arolygu tatws sy'n tarddu o'r Aifft heb eu newid (rheoliad 6).

Cyflwynir ffioedd newydd ynglŷn â thatws sy'n tarddu o Libanus fel a ganlyn: £31.86 am gais am drwydded (Atodlen 5, eitem 5) a £117.39 am arolygu (rheoliad 7).

Mae rheoliad 8 yn nodi canlyniadau peidio â thalu unrhyw ffi.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, mae asesiadau effaith rheoleiddiol wedi eu paratoi (ar gyfer mwyafrif y ffioedd a bennir) o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn. O ran ffioedd mewn perthynas â thatws sy'n tarddu o Libanus, nid ystyriwyd bod angen cynnal asesiad effaith rheoleiddiol. Gellir cael copïau o'r asesiadau effaith rheoleiddiol oddi wrth y Tîm Amgylchedd Naturiol ac Amaeth, Llywodraeth Cymru, Parc Cathays, Caerdydd CF10 3NQ.

(2) fees for import inspection documentary and identity checks increase by 24.5% (regulation 2 and Schedule 3);

(3) fees relating to seed potato inspections remain unchanged (regulation 3 and Schedule 4);

(4) licensing fees increase by 2.2% (regulation 4 and Schedule 5);

(5) fees for plant passporting services increase by 21.2% (regulation 5); and

(6) fees for inspections of potatoes originating in Egypt remain unchanged (regulation 6).

New fees are introduced in relation to potatoes originating in Lebanon as follows: £31.86 for an application for a licence (Schedule 5, item 5) and £117.39 for an inspection (regulation 7).

Regulation 8 sets out the consequences of failure to pay any fee.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, regulatory impact assessments have been prepared (for the majority of fees specified) as to the likely costs and benefits of complying with these Regulations. With regard to fees in relation to potatoes originating in Lebanon, it was not considered necessary to carry out a regulatory impact assessment. Enwi, cymhwyso, cychwyn a dehongli

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Iechyd Planhigion (Ffioedd) (Cymru) 2014. Maent yn gymwys o ran Cymru a deuant i rym ar 2 Awst 2014.

(2) Yn y Rheoliadau hyn—

- (a) ystyr “y Gyfarwyddeb” (“*the Directive*”) yw Cyfarwyddeb y Cyngor 2000/29/EC ar fesurau i amddiffyn rhag dwyn i mewn i'r Gymuned organebau sy'n niweidiol i blanhigion neu gynhyrchion planhigion, a rhag i'r organebau hynny ymledu o fewn y Gymuned(3); ac
- (b) ystyr “y GIP” (“*the PHO*”) yw Gorchymyn Iechyd Planhigion (Cymru) 2006(4).

**The Plant Health (Fees) (Wales)
Regulations 2014**

Made 6 July 2014

Laid before the National Assembly for Wales 8 July 2014

Coming into force 2 August 2014

The Welsh Ministers make these Regulations, with the consent of the Treasury, in exercise of the powers conferred by section 56(1) and (2) of the Finance Act 1973(1) and now vested in them(2).

Title, application, commencement and interpretation

1.—(1) The title of these Regulations is the Plant Health (Fees) (Wales) Regulations 2014. They apply in relation to Wales and come into force on 2 August 2014.

(2) In these Regulations—

- (a) “the Directive” (“*y Gyfarwyddeb*”) means Council Directive 2000/29/EC on protective measures against the introduction into the Community of organisms harmful to plants or plant products and against their spread within the Community(3); and
- (b) “the PHO” (“*y GIP*”) means the Plant Health (Wales) Order 2006(4).

(3) Mae i'r termau a ddefnyddir yn y Rheoliadau hyn, ac y defnyddir eu cyfystyron Saesneg yn y Gyfarwyddeb, yr un ystyr yn y Rheoliadau hyn ag a roddir i'r cyfystyron Saesneg yn y Gyfarwyddeb.

Ffioedd arolygu mewnforio

2.—(1) Mae'r rheoliad hwn yn gymwys o ran llwyth o'r canlynol, neu ran o lwyth o'r fath sy'n cynnwys—

- (a) planhigion, cynhyrchion planhigion a gwrthrychau eraill o ddisgrifiad a bennir yng ngholofn 1 o Atodlen 1 a restrir yn Rhan B o Atodiad V i'r Gyfarwyddeb, neu
- (b) hadau *Solanaceae*, pa un a restrir hwy ai peidio yn y Rhan honno,

a ddygir i mewn i Gymru o wlad neu diriogaeth ac eithrio un sydd o fewn yr Undeb Ewropeaidd neu sy'n destun cytundeb a wnaed o dan erthygl 12(6) o'r GIP.

(2) Ar yr adeg y mewnforig llwyth y mae'r rheoliad hwn yn gymwys iddo, rhaid i'r mewnforigwr dalu i Weinidogion Cymru—

- (a) y ffi a bennir—
 - (i) yng ngholofn 3 o Atodlen 1 mewn perthynas â llwyth o blanhigion, cynnyrch planhigion neu wrthrych arall a restrir yng ngholofn 1 o'r Atodlen honno, neu mewn perthynas â rhan o lwyth o'r fath, ac eithrio llwyth o blanhigion neu gynnyrch planhigion, neu ran o lwyth o'r fath, y mae paragraff (ii) o'r is-baragraff hwn yn gymwys iddo, a
 - (ii) yng ngholofn 4 o Atodlen 2 mewn perthynas â llwyth o blanhigion neu gynnyrch planhigion a restrir yng ngholofn 1 o'r Atodlen honno ac sy'n tarddu o wlad a restrir yng ngholofn 3 o'r Atodlen honno, neu mewn perthynas â rhan o lwyth o'r fath; a
- (b) y ffioedd a bennir yng ngholofn 3 o Atodlen 3 am wiriad dogfennol a gwiriad adnabod.

(3) Ond, pan gynhelir gwiriad iechyd planhigion ar lwyth y tu allan i oriau gwaith yn ystod y dydd, a hynny ar gais y mewnforigwr neu unrhyw berson arall sy'n gyfrifol am y llwyth, y ffi sy'n daladwy o dan baragraff (2)(a) mewn perthynas â'r llwyth hwnnw yw—

- (a) y ffi a bennir yng ngholofn 4 o Atodlen 1 i'r graddau (os o gwbl) y mae'r llwyth yn un y mae paragraff (2)(a)(i) yn gymwys iddo; neu
- (b) y ffi a bennir yng ngholofn 5 o Atodlen 2 i'r graddau (os o gwbl) y mae'r llwyth yn un y mae paragraff (2)(a)(ii) yn gymwys iddo.

(3) Terms used in these Regulations which are also used in the Directive have the meaning they have in the Directive.

Import inspection fees

2.—(1) This regulation applies in relation to a consignment of, or such part of a consignment as consists of—

- (a) plants, plant products and other objects of a description specified in column 1 of Schedule 1 that are listed in Part B of Annex V to the Directive, or
- (b) seeds of *Solanaceae* whether or not listed in that Part,

that are introduced into Wales from a country or territory other than one within the European Union or are the subject of an agreement made under article 12(6) of the PHO.

(2) Upon import of a consignment to which this regulation applies, an importer must pay to the Welsh Ministers—

- (a) the fee specified—
 - (i) in column 3 of Schedule 1 in respect of a consignment of, or such part of a consignment as consists of, a plant, plant product or other object listed in column 1 of that Schedule, other than a consignment of, or such part of a consignment as consists of, a plant or plant product to which paragraph (ii) of this sub-paragraph applies, and
 - (ii) in column 4 of Schedule 2 in respect of a consignment of, or such part of a consignment as consists of, a plant or plant product listed in column 1 of that Schedule and originating from a country listed in column 3 of that Schedule; and
- (b) the fees specified in column 3 of Schedule 3 for a documentary check and an identity check.

(3) But where, at the request of an importer or any other person responsible for the consignment, a plant health check is carried out on a consignment outside daytime working hours, the fee payable under paragraph (2)(a) in respect of that consignment is—

- (a) the fee specified in column 4 of Schedule 1 to the extent (if any) that the consignment is a consignment to which paragraph (2)(a)(i) applies; or
- (b) the fee specified in column 5 of Schedule 2 to the extent (if any) that the consignment is a consignment to which paragraph (2)(a)(ii) applies.

(4) Yn y rheoliad hwn, ystyr “oriau gwaith yn ystod y dydd” (“*daytime working hours*”) yw unrhyw amser rhwng yr oriau 8.30 a.m. a 5.00 p.m. ar unrhyw ddiwrnod ac eithrio dydd Sadwrn, dydd Sul, Dydd Nadolig, Dydd Gwener y Groglith neu ddiwrnod sy’n wyl banc yng Nghymru o dan Ddeddf Bancio a Thrafodion Ariannol 1971(1).

Tatws hadyd: ffioedd

3.—(1) Mae’r ffioedd a bennir yn Atodlen 4 yn daladwy mewn perthynas â’r swyddogaethau a bennir yng ngholofn 1 o’r Atodlen honno, sy’n ymwneud â chais am y canlynol—

- (a) ardystiad o datws hadyd yn unol â rheoliad 9 o Reoliadau Tatws Hadyd (Cymru) 2006(2);
- (b) awdurdodiad i farchnata tatws hadyd yn unol â rheoliad 8 o’r Rheoliadau hynny.

(2) Mae’r ffi sy’n daladwy mewn perthynas â swyddogaeth yn ddarostyngedig i unrhyw leiafswm ffi a bennir yng ngholofn 3 o Atodlen 4 mewn perthynas â’r swyddogaeth honno.

(3) Rhaid talu’r ffi mewn perthynas â swyddogaeth a bennir yn Atodlen 4 i Weinidogion Cymru neu i unrhyw berson a awdurdodir gan Weinidogion Cymru i gyflawni’r swyddogaeth honno o dan Reoliadau Tatws Hadyd (Cymru) 2006 ar ran Gweinidogion Cymru.

Fffioedd am drwyddedau iechedd planhigion

4.—(1) Mae’r ffioedd sy’n daladwy o dan y rheoliad hwn yn ymwneud â thrwydded a ddisgrifir yn erthygl 40 neu 41 o’r GIP.

(2) Mewn perthynas â chais neu arolygiad o fath a ddisgrifir yng ngholofn 2 o Atodlen 5, rhaid i berson dalu i Weinidogion Cymru y ffi a bennir yng ngholofn 3 o’r Atodlen honno mewn perthynas â’r math hwnnw o gais neu arolygiad.

Fffioedd am awdurdodi pasbortau planhigion

5.—(1) Rhaid talu’r ffi a bennir ym mharagraff (2) i Weinidogion Cymru mewn perthynas ag arolygiad (gan gynnwys arolygiad o gofnodion busnes) a gyflawnir mewn cysylltiad â’r canlynol—

- (a) cais am awdurdod; neu
- (b) sicrhau y cydymffurfir ag unrhyw ofynion a osodir ar ddeiliad awdurdod.

(4) In this regulation “daytime working hours” (“*oriau gwaith yn ystod y dydd*”) means any time between the hours of 8.30 a.m. and 5.00 p.m. on any day except a Saturday, Sunday, Christmas Day, Good Friday or a day which is a bank holiday in Wales under the Banking and Financial Dealings Act 1971(1).

Seed potatoes: fees

3.—(1) The fees specified in Schedule 4 are payable in respect of the functions specified in column 1 of that Schedule, which relate to an application for—

- (a) certification of seed potatoes in accordance with regulation 9 of the Seed Potatoes (Wales) Regulations 2006(2);
- (b) an authorisation to market seed potatoes in accordance with regulation 8 of those Regulations.

(2) The fee payable in respect of a function is subject to any minimum fee specified in column 3 of Schedule 4 in relation to that function.

(3) The fee in respect of a function specified in Schedule 4 must be paid to the Welsh Ministers or to any person authorised by the Welsh Ministers to carry out that function under the Seed Potatoes (Wales) Regulations 2006 on behalf of the Welsh Ministers.

Plant health licence fees

4.—(1) Fees payable under this regulation relate to a licence described in article 40 or 41 of the PHO.

(2) In respect of an application or inspection of a type described in column 2 of Schedule 5, a person must pay to the Welsh Ministers the fee specified in column 3 of that Schedule in relation to that type of application or inspection.

Plant passport authorisation fees

5.—(1) The fee specified in paragraph (2) must be paid to the Welsh Ministers in respect of an inspection (which may include an inspection of business records) carried out in connection with—

- (a) an application for an authority; or
- (b) ensuring compliance with any requirements imposed on the holder of an authority.

(3) Yn y rheoliad hwn ystyr “awdurdod” (“*authority*”) yw awdurdod i ddyroddi pasbortau planhigion a roddir o dan erthygl 8 o Orchymyn Iechyd Planhigion (*Phytophthora ramorum*) (Cymru) 2006(3) neu erthygl 29 o’r GIP.

Tatws sy’n tarddu o’r Aiff: ffioedd

6.—(1) Pan fo arolygydd yn cymryd sampl o datws sy’n tarddu o’r Aiff, er mwyn canfod, at ddibenion paragraff 5 o’r Atodiad i’r Penderfyniad, a yw’r tatws hynny wedi eu heintio â *Ralstonia solanacearum* (Smith) Yabuuchi et al., rhaid i’r mewnoforiwr dalu i Weinidogion Cymru ffi o £117.36 mewn perthynas â phob lot y cymerir sampl ohoni.

(2) Yn y rheoliad hwn ystyr “y Penderfyniad” (“*the Decision*”) yw Penderfyniad Gweithredu’r Comisiwn 2011/787/EU sy’n awdurdodi Aelod-wladwriaethau i weithredu mesurau argyfwng dros dro yn erbyn lledaenu *Ralstonia solanacearum* (Smith) Yabuuchi et al. mewn cysylltiad â’r Aiff(4).

Tatws sy’n tarddu o Libanus: ffioedd

7.—(1) Pan fo arolygydd yn cymryd sampl o datws sy’n tarddu o Libanus, er mwyn canfod, at ddibenion Erthygl 4 o’r Penderfyniad, a yw’r tatws hynny wedi eu heintio â *Clavibacter michiganensis* isrywogaeth *Sepedonicus* (Spieckermann a Kotthoff) Davis et al., rhaid i’r mewnoforiwr dalu i Weinidogion Cymru ffi o £117.36 mewn perthynas â phob lot y cymerir sampl ohoni.

(2) Yn y rheoliad hwn ystyr “y Penderfyniad” (“*the Decision*”) yw Penderfyniad Gweithredu’r Comisiwn 2013/413/EU sy’n awdurdodi Aelod-wladwriaethau i ddarparu ar gyfer rhanddirymu darpariaethau penodol yng Nghyfarwyddeb y Cyngor 2000/29/EC mewn perthynas â thatws, ac eithrio tatws a fwriedir ar gyfer eu plannu, sy’n tarddu o ranbarthau Akkar a Bekaa yn Libanus(5).

(2) The fee is £46.10(1) for each quarter of an hour or part of quarter of an hour (including time spent on an inspection, on travelling and on associated administration), subject to a minimum fee of £92.19(2) per visit.

(3) In this regulation “authority” (“*awdurdod*”) means an authority to issue plant passports conferred under article 8 of the Plant Health (*Phytophthora ramorum*) (Wales) Order 2006(3) or article 29 of the PHO.

Potatoes originating in Egypt: fees

6.—(1) Where an inspector takes a sample of potatoes originating in Egypt in order to ascertain whether, for the purposes of paragraph 5 of the Annex to the Decision, those potatoes are infected with *Ralstonia solanacearum* (Smith) Yabuuchi et al., the importer must pay to the Welsh Ministers £117.36 in respect of each lot sampled.

(2) In this regulation “the Decision” (“*y Penderfyniad*”) means Commission Implementing Decision 2011/787/EU authorising Member States temporarily to take emergency measures against the dissemination of *Ralstonia solanacearum* (Smith) Yabuuchi et al. as regards Egypt(4).

Potatoes originating in Lebanon: fees

7.—(1) Where an inspector takes a sample of potatoes originating in Lebanon in order to ascertain whether, for the purposes of Article 4 of the Decision, those potatoes are infected with *Clavibacter michiganensis* subspecies *Sepedonicus* (Spieckermann and Kotthoff) Davis et al., the importer must pay to the Welsh Ministers £117.36 in respect of each lot sampled.

(2) In this regulation “the Decision” (“*y Penderfyniad*”) means Commission Implementing Decision 2013/413/EU authorising Member States to provide for derogations from certain provisions of Council Directive 2000/29/EC in respect of potatoes, other than potatoes intended for planting, originating in the regions of Akkar and Bekaa of Lebanon(5).

(1) Y ffi gyfatebol a oedd yn daladwy o dan reoliad 5(2) o Reoliadau Iechyd Planhigion (Ffioedd) (Cymru) 2013 (O.S. 2013/1700 (Cy. 164)) cyn i’r Rheoliadau hyn gychwyn oedd £38.05.
(2) Y ffi isaf gyfatebol a oedd yn daladwy o dan reoliad 5(2) o Reoliadau Iechyd Planhigion (Ffioedd) (Cymru) 2013 cyn i’r Rheoliadau hyn gychwyn oedd £76.10.

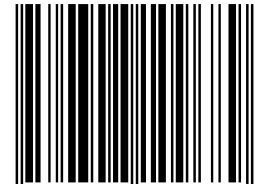
