The Environmental Permitting (England and Wales) (Amendment) (No.2) Regulations 2015

The Secretary of State, in relation to England, and the Welsh Ministers, in relation to Wales, have in accordance with section 2(4) of the Pollution Prevention and Control Act 1999(a) consulted—

- (a) the Environment Agency;
- (b) the Natural Resources Body for Wales;
- (c) such bodies or persons appearing to them to be representative of the interests of local government, industry, agriculture and small businesses as they consider appropriate; and
- (d) such other bodies or persons as they consider appropriate.

The Secretary of State, in relation to England, and the Welsh Ministers, in relation to Wales, make these Regulations in exercise of section 2 of, and Schedule 1 to, that Act(b).

Citation and commencement

1.—(1) These Regulations may be cited as the Environmental Permitting (England and Wales) (Amendment) (No.2) Regulations 2015 and come into force on 15th June 2015.

(b) in the opening words of paragraph 11, after "Paragraphs 7 to 10" insert "and 12 to 15".
