Mae'r Rheoliadau hyn yn diwygio Rheoliadau Tatws Hadyd (Cymru) 2016 (O.S. 2016/106 (Cy. 52)).

Mae'r Rheoliadau hyn yn gweithredu Cyfarwydddeb Weithredu'r Comisiwn (EU) 2016/317 (OJ L 60, 5.3.2016, tt. 72–75), sy'n diwygio Cyfarwydddeb y Cyngor 2002/56/EC (OJ L 193, 20.7.2002, tt. 60–73), drwy ddiwygio'r gofynion ar gyfer y label swyddogol ar datws hadyd sylfaenol ac ardystiedig yn Rheoliadau 2016.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations amend the Seed Potatoes (Wales) Regulations 2016 (S.I. 2016/106 (W.52)).

These Regulations implement Commission Implementing Directive (EU) 2016/317 (OJ L 60, 5.3.2016, p. 72–75), amending Council Directive 2002/56/EC (OJ L 193, 20.7.2002, p. 60–73), by amending the requirements for the official label on basic and certified seed potatoes in the 2016 Regulations.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddir gan adran 16 o Ddeddf Amrywogaethau a Hadau Planhigion 1964(1), yn gwneud y Rheoliadau a ganlyn.

The Welsh Ministers, in exercise of the powers conferred by section 16 of the Plant Varieties and Seeds Act 1964(1), make the following Regulations.

Yn unol ag adran 16(1) o'r Ddeddf honno, mae Gweinidogion Cymru wedi ymgynghori â chynrychiolwyr y buddiannau hynny y mae'n ymddangos i Weinidogion Cymru yr effeithir arnynt.

In accordance with section 16(1) of that Act, the Welsh Ministers have consulted with representatives of such interests as appear to the Welsh Ministers to be concerned.

**Title, commencement and application**

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Tatws Hadyd (Cymru) (Diwygio) 2017.

1.—(1) The title of these Regulations is the Seed Potatoes (Wales) (Amendment) Regulations 2017.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru a deuant i rym ar 18 Mai 2017.

(2) These Regulations apply in relation to Wales and come into force on 18 May 2017.

(1) 1964 (p.14); diwygiwyd adran 16(1) a mewnosodwyd adran 16(1A) gan baragraff 5 o Atodlen 4 i Ddeddf y Cymunedau Ewropeaidd 1972 (p. 68). Trosglwyddwyd swyddogaethau'r Gweinidog, i'r graddau yr oeddent yn arferadwy o ran Cymru, i'r Ysgrifennydd Gwladol gan erthygl 2 o Orchymyn Trosglwyddo Swyddogaethau (Cymru) (Rhif 1) 1978 (O.S. 1978/272), ac Atodlen 1 iddo. Trosglwyddwyd y swyddogaethau hynny wedi hynny i Gynulliad Cenedlaethol Cymru gan erthygl 2 o Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672) ac Atodlen 1 iddo. Mae swyddogaethau Cynulliad Cenedlaethol Cymru wedi eu breinio bellach yng Ngweinidogion Cymru yn rhinwedd adran 162 o Ddeddf Llywodraeth Cymru 2006 (p. 32) a pharagraff 30 o Atodlen 11 iddi.

(1) 1964 (c.14); Section 16(1) was amended and section 16(1A) was inserted by the European Communities Act 1972 (c. 68), Schedule 4, paragraph 5. The functions of the Minister, so far as exercisable in relation to Wales, transferred to the Secretary of State by article 2 of, and Schedule 1 to, the Transfer of Functions (Wales)(No.1) Order 1978 (S.I. 1978/272). Those functions were then transferred to the National Assembly for Wales by article 2 of, and Schedule 1 to, the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672). The functions of the National Assembly for Wales now vest in the Welsh Ministers by virtue of section 162 of, and paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (c.32).

## Diwygio Rheoliadau Tatws Hadyd (Cymru) 2016

2.—(1) Mae Rheoliadau Tatws Hadyd (Cymru) 2016(1) wedi eu diwygio fel a ganlyn.

(2) Yn Rheoliad 3 (dehongli: offerynnau Ewropeaidd) yn lle'r diffiniad o “y Gyfarwyddeb” rhodder—

“ystyr “y Gyfarwyddeb” (“*the Directive*”) yw Cyfarwyddeb y Cyngor 2002/56/EC ar farchnata tatws hadyd(2);”.

(3) Yn Rhan 1 o Atodlen 2 (labeli swyddogol a dogfennau swyddogol), ar ôl paragraff 7(b)(i), mewnosoder—

“(ia) rhif cyfresol wedi ei neilltuo yn swyddogol;”.

## Amendment to the Seed Potatoes (Wales) Regulations 2016

2.—(1) The Seed Potatoes (Wales) Regulations 2016(1) are amended as follows.

(2) In Regulation 3 (interpretation: European instruments) for the definition of “the Directive” substitute—

““the Directive” (“ y Gyfarwyddeb ”) means Council Directive 2002/56/EC on the marketing of seed potatoes(2);”.

(3) In Part 1 of Schedule 2 (official labels and official documents), after paragraph 7(b)(i), insert—

“(ia) an officially assigned serial number;”.

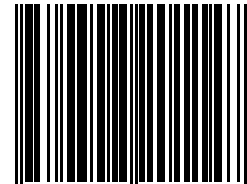
