**EXPLANATORY NOTE**

Mae'r Gorchymyn hwn yn diwygio Gorchymyn Trwyddedu Morol (Gweithgareddau Esempt) (Cymru) 2011 ("Gorchymyn 2011"), sy'n cyfeirio at Gyfarwyddeb 2008/98/EC Senedd Ewrop a'r Cyngor dyddiedig 19 Tachwedd 2008 ar wastraff ac yn diddymu Cyfarwyddebau penodol (OJ Rhif L 312, 22.11.2008, t. 3.) ("y Gyfarwyddeb Fframwaith Gwastraff").

This Order amends the Marine Licensing (Exempted Activities) (Wales) Order 2011 ("the 2011 Order"), which refers to Directive 2008/98/EC of the European Parliament and of the Council of 19 November 2008 on waste and repealing certain Directives (OJ No. L 312, 22.11.2008, p. 3) ("the Waste Framework Directive").

Diwygiwyd y Gyfarwyddeb Fframwaith Gwastraff gan Reoliad y Cyngor (UE) 2017/997 dyddiedig 8 Mehefin 2017 sy'n diwygio Atodiad III i Gyfarwyddeb 2008/98/EC Senedd Ewrop a'r Cyngor o ran y nodwedd beryglus HP 14 'Ecowenwynig' (OJ Rhif L 150, 14.6.2017, p. 1).

The Waste Framework Directive was amended by Council Regulation (EU) 2017/997 of 8 June 2017 amending Annex III to Directive 2008/98/EC of the European Parliament and of the Council as regards the hazardous property HP 14 'Ecotoxic' (OJ No. L 150, 14.6.2017, p. 1).

Mae erthygl 2 o'r Gorchymyn hwn yn diwygio'r cyfeiriad at y Gyfarwyddeb Fframwaith Gwastraff yn erthygl 3 o Orchymyn 2011 i gyfeirio at y Gyfarwyddeb fel y'i diwygwyd ddiwethaf gan Reoliad y Cyngor (UE) 2017/997.

Article 2 of this Order amends the definition of the Waste Framework Directive in article 3 of the 2011 Order to refer to that Directive as last amended by Council Regulation (EU) 2017/997.

Mae erthygl 3 yn dirymu Gorchymyn Trwyddedu Morol (Gweithgareddau Esempt) (Cymru) (Diwygio) 2016.

Article 3 revokes the Marine Licensing (Exempted Activities) (Wales) (Amendment) Order 2016.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal asesiadau effaith rheoleiddiol ar gyfer is-ddeddfwriaeth mewn perthynas â'r Gorchymyn hwn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n deillio o gydymffurfio â'r Gorchymyn hwn.

The Welsh Ministers' Code of Practice on the carrying out of regulatory impact assessments for subordinate legislation was considered in relation to this Order. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order.

Mae Gweinidogion Cymru wedi eu dynodi(1) at ddibenion adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972(2) mewn perthynas ag atal, lleihau a rheoli gwastraff(3).

The Welsh Ministers are designated(1) for the purposes of section 2(2) of the European Communities Act 1972(2) in relation to the prevention, reduction and management of waste(3).

Mae Gweinidogion Cymru yn gwneud y Gorchymyn hwn drwy arfer y pwerau a roddwyd gan adran 2(2) o'r Ddeddf honno.

The Welsh Ministers make this Order in exercise of the powers conferred by section 2(2) of that Act.

(2) Yn erthygl 3 (dehongli), yn y diffiniad o “y Gyfarwyddeb Fframwaith Gwastraff” (“*the Waste Framework Directive*”), yn lle “fel y'i diwygiwyd ddiwethaf gan Gyfarwyddeb Comisiwn (UE) 2015/1127”, rhodder “fel y'i diwygiwyd ddiwethaf gan Reoliad y Cyngor (UE) 2017/997(2)”.

## Title and commencement

1.—(1) The title of this Order is the Marine Licensing (Exempted Activities) (Wales) (Amendment) Order 2018.

## Amendment of the Marine Licensing (Exempted Activities) (Wales) Order 2011

2.—(1) The Marine Licensing (Exempted Activities) (Wales) Order 2011(1) is amended as follows.

(2) In article 3 (interpretation), in the definition of “the Waste Framework Directive” (“*y Gyfarwyddeb Fframwaith Gwastraff*”), for “as last amended by Commission Directive (EU) 2015/1127”, substitute “as last amended by Council Regulation (EU) 2017/997(2)”.

3. The Marine Licensing (Exempted Activities) (Wales) (Amendment) Order 2016(3) is revoked.
