  - (a) tynnu'r diffiniad o "Cyfarwyddeb 80/777" o reoliad 2(1) (dehongli), mewnosod diffiniad o "Cyfarwyddeb 2009/54" a rhoi diffiniad newydd o "ddŵr mwynol naturiol" yn lle'r hen un (rheoliad 3);
  - (b) rhoi cyfeiriadau at "Cyfarwyddeb 2009/54" yn lle'r cyfeiriadau at "Cyfarwyddeb 80/777" sy'n ymddangos mewn darpariaethau penodol (rheoliad 4);
  - (c) gwneud mân newidiadau i eiriad rheoliad 8(1)(c) ac (f) a (4), rheoliad 9(2)(c) a pharagraff 4 o Atodlen 4, i adlewyrchu mân wahaniaethau rhwng darpariaethau Cyfarwyddeb 2009/54 (y mae'r darpariaethau domestig hynny bellach yn eu gweithredu) a'r darpariaethau cyfatebol yng Nghyfarwyddeb 80/777 (yr oedd y darpariaethau domestig hynny gynt yn eu gweithredu) (rheoliadau 5, 6 a 7 (1));

The Natural Mineral Water, Spring Water and Bottled Drinking Water (Wales) (Amendment) Regulations 2009

**EXPLANATORY NOTE**

(*This note is not part of the Regulations*)

1. These Regulations amend the Natural Mineral Water, Spring Water and Bottled Drinking Water (Wales) Regulations 2007 (S.I. 2007/3165 (W.276)) ("the principal Regulations") and in so doing implement Directive 2009/54/EC of the European Parliament and of the Council on the exploitation and marketing of natural mineral waters (Recast) (OJ No. L164, 26.6.2009, p.45).
  - (a) removing the definition of "Directive 80/777" from regulation 2(1) (interpretation), inserting a definition of "Directive 2009/54" and substituting a new definition of "natural mineral water" (regulation 3);
  - (b) substituting references to "Directive 2009/54" for the references to "Directive 80/777" that appear in specified provisions (regulation 4);
  - (c) making minor changes to the wording of regulation 8(1)(c) and (h) and (4), regulation 9(2)(c) and paragraph 4 of Schedule 4, to reflect minor differences between the provisions of Directive 2009/54 (which those domestic provisions now implement) and the corresponding provisions of Directive 80/777 (which those domestic provisions formerly implemented) (regulations 5, 6 and 7(1));
2. The Regulations amend the principal Regulations by—
  - (a) removing the definition of "Directive 80/777" from regulation 2(1) (interpretation), inserting a definition of "Directive 2009/54" and substituting a new definition of "natural mineral water" (regulation 3);
  - (b) substituting references to "Directive 2009/54" for the references to "Directive 80/777" that appear in specified provisions (regulation 4);
  - (c) making minor changes to the wording of regulation 8(1)(c) and (h) and (4), regulation 9(2)(c) and paragraph 4 of Schedule 4, to reflect minor differences between the provisions of Directive 2009/54 (which those domestic provisions now implement) and the corresponding provisions of Directive 80/777 (which those domestic provisions formerly implemented) (regulations 5, 6 and 7(1));

- (dd) gwneud mân gywiriadau penodol i fersiwn Gymraeg y prif Reoliadau (rheoliad 8).

**3.** Nid oes asesiad effaith rheoleiddiol llawn wedi'i lunio ar gyfer yr offeryn hwn, gan na ragwelir y bydd yr offeryn yn effeithio o gwbl ar y sector preifat na'r sector gwirfoddol.

- (d) substituting, for the provision under which spring water may be transported from spring to bottling plant in containers not for distribution to the ultimate consumer if water from the spring was so transported before 23 November 1996, one which changes that date to 13 December 1996 (regulation 7(2));
- (e) substituting, for the provision under which natural mineral water and spring water must be free of specified organisms, one which lays down that such water must be free of such organisms both at source and during marketing (regulation 7(3)); and
- (f) making certain minor corrections to the Welsh version of the principal Regulations (regulation 8).

**3.** A full impact assessment has not been produced for this instrument as no impact on the private or voluntary sectors is foreseen.

The Natural Mineral Water, Spring Water and Bottled Drinking Water (Wales) (Amendment) Regulations 2009

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 16(1), 17(1), 26(1)(a) and (3), 31 and 48(1) of and paragraphs 1 and 4(b) of Schedule 1 to the Food Safety Act 1990(1) and now vested in them (2).

In accordance with section 48(4A) of that Act, they have taken into account relevant advice given by the Food Standards Agency.

As required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in

3. Yn rheoliad 2(1) (dehongli)—

(1) Dileer y diffiniad o "Cyfarwyddeb 80/777"; a

(2) yn union ar ôl y diffiniad o "Cyfarwyddeb 2003/40" mewnosoder y diffiniad a ganlyn—

"ystyr "Cyfarwyddeb 2009/54" ("Directive 2009/54") yw Cyfarwyddeb 2009/54 Senedd Ewrop a'r Cyngor ar ddatblygu a marchnata dyfroedd mwynol naturiol (3);";

(3) yn lle'r diffiniad o "dŵr mwynol naturiol" rhodder y diffiniad a ganlyn—

"ystyr "dŵr mwynol naturiol" ("natural mineral water") yw dŵr—

- (a) sy'n iachus yn ficrobiolegol;
- (b) sy'n tarddu o lefel trwythiad neu ddyddodion tandaearol ac sy'n codi allan o ffynnon a dapiwyd mewn allanfa neu allanfeydd naturiol neu wedi'u tyllu;

## Title, commencement and interpretation

1.—(1) The title of these Regulations is the Natural Mineral Water, Spring Water and Bottled Drinking Water (Wales) (Amendment) Regulations 2009 and they come into force on 16 July 2009.

(2) In these Regulations "the principal Regulations" ("y prif Reoliadau") means the Natural Mineral Water, Spring Water and Bottled Drinking Water (Wales) Regulations 2007(2).

## Amendment of the Natural Mineral Water, Spring Water and Bottled Drinking Water (Wales) Regulations 2007

2. The principal Regulations are amended in accordance with regulations 3 to 8.

3. In regulation 2(1) (interpretation)—

(1) the definition of "Directive 80/777" is deleted; and

(2) immediately after the definition of "Directive 2003/40" there is inserted the following definition—

"Directive 2009/54" ("Cyfarwyddeb 2009/54") means Directive 2009/54 of the European Parliament and of the Council on the exploitation and marketing of natural mineral waters(3);";

(3) for the definition of "natural mineral water" there is substituted the following definition—

"natural mineral water" ("dŵr mwynol naturiol") means water which—

- (a) is microbiologically wholesome;
- (b) originates in an underground water table or deposit and emerges from a spring tapped at one or more natural or bore exits;
- (c) can be clearly distinguished from ordinary drinking water on account of the following characteristics having been preserved intact because of the underground origin of the water, which origin must have been protected from all risk of pollution—

**5.** Yn rheoliad 8 (marcio, labelu a hysbysebu dŵr mwynol naturiol)—

(1) yn lle paragraff 1(c) rhodder y paragraff a ganlyn—

"(c) unrhyw fynegiad, dynodiad, marc masnachol, enw brand, darlun neu arwydd arall, p'un ai'n ffigurol ai peidio, y mae'r defnydd ohonynt yn awgrymu nodweddion nad yw'r dŵr yn meddu arnynt, yn benodol o ran ei darddiad, dyddiad yr awdurdodiad i'w ddatblygu, canlyniadau dadansoddi neu unrhyw gyfeiriadau tebyg at warantau diliysu;";

(2) yn lle paragraff (1)(f) rhodder y paragraff a ganlyn—

"(f) disgrifiad gwerthu heblaw—

(i) yn achos dŵr mwynol naturiol eferw, un o'r canlynol, fel y bo'n briodol—

- (ii) its original purity;
- (d) is for the time being recognised pursuant to and in accordance with regulation 4".

**4.—(1)** In each of the provisions referred to in paragraph (2), for the reference to "Directive 80/777" there is substituted a reference to "Directive 2009/54".

(2) The provisions are regulation 2(2) and (3) and regulation 4(1)(b) and (c) and (8) (recognition as natural mineral water).

**5.** In regulation 8 (marking, labelling and advertising of natural mineral water)—

(1) for paragraph (1)(c) there is substituted the following paragraph—

"(c) any indication, designation, trade mark, brand name, picture or other sign, whether figurative or not, the use of which suggests a characteristic which the water does not possess, in particular as regards its origin, the date of authorisation to exploit it, the results of analyses or any similar references to guarantees of authenticity;";

(2) for paragraph (1)(h) there is substituted the following paragraph—

"(h) a sales designation other than—

(i) in the case of an effervescent natural mineral water, one of the following, as appropriate—

(aa) "naturally carbonated natural mineral water" to describe water whose content of carbon dioxide from the spring after decanting, if any, and bottling is the same as at source, taking into account where appropriate the reintroduction of a quantity of carbon dioxide from the same water table or deposit equivalent to that released in the course of those operations and subject to the usual technical tolerances,

(bb) "natural mineral water fortified with gas from the spring" to describe water whose content of carbon dioxide from the same water table or the same deposit after decanting, if any, and bottling is greater than that established at source, or

(cc) "carbonated natural mineral water" to describe water to which has been added carbon dioxide of an origin

- 6.** Yn rheoliad 9 (gwerthu dŵr mwynol naturiol) yn lle paragraff (2)(c) rhodder y paragraff a ganlyn—

"(c) pan fo cyfanswm cyfrif cytref y dŵr hwnnw y gellir ei adfywio'n fwy na'r hyn fyddai canlyniad cynnydd normal yn y cyfrif bacteriol a oedd ganddo yn y ffynhonnell; neu".

- 7.** Yn Atodlen 4 (gofynion datblygu a photelu ar gyfer dŵr mwynol naturiol a dŵr ffynnon)—

- (1) Yn lle paragraff 4 rhodder y paragraff a ganlyn—

"**4** Rhaid i'r amodau ar gyfer datblygu, yn enwedig, y cyfarpar golchi a photelu, fodloni gofynion hylendid. Yn benodol, rhaid bod y cynwysyddion wedi'u trin neu eu gweithgynhyrchu mewn modd sy'n osgoi effeithiau andwyol ar nodweddion microbiolegol a chemegol y dŵr naturiol."

- (2) yn lle paragraff 5(3) rhodder y paragraff a ganlyn—

"(3) Caniateir i ddŵr a ddosberthir i'r defnyddiwr olaf mewn potel wedi'i marcio neu wedi'i labelu â'r disgrifiad "dŵr ffynnon" gael ei gludo o'r ffynnon i'r man potelu mewn cynhwysydd nad yw ar gyfer ei ddosbarthu i'r defnyddiwr olaf os cludwyd dŵr o'r ffynnon honno yn y fath fodd ar 13 Rhagfyr 1996 neu cyn hynny.;" a

- (3) yn lle paragraff 8 rhodder y paragraff a ganlyn—

**"8.** Yn ei ffynhonnell ac yn ystod ei farchnata, rhaid i'r dŵr fod yn rhydd rhag—

- (a) parasitaiad a micro organebau pathogenig;
- (b) *Escherichia coli* a chloriformau a streptococi ysgarthol eraill mewn unrhyw sampl 250 ml a archwili;

other than the water table or deposit from which the water comes; and

- (ii) in the case of a natural mineral water other than an effervescent natural mineral water, "natural mineral water"'; and

- (3) for paragraph (4) there is substituted the following paragraph—

"(4) No person may advertise any natural mineral water under any indication, designation, trade mark, brand name, picture or other sign, whether figurative or not, the use of which suggests a characteristic which the water does not possess, in particular as regards its origin, the date of authorisation to exploit it, the results of analyses or any similar references to guarantees of authenticity.".

- 6.** In regulation 9 (sale of natural mineral water) for paragraph (2)(c) there is substituted the following paragraph—

"(c) where the revivable total colony count of that water is in excess of that which would result from the normal increase in the bacterial count which it had at source; or".

- 7.** In Schedule 4 (exploitation and bottling requirements for natural mineral water and spring water)—

- (1) for paragraph 4 there is substituted the following paragraph—

"**4.** The conditions of exploitation, particularly the washing and bottling equipment, must meet hygiene requirements. In particular, the containers must be so treated or manufactured as to avoid adverse effects on the microbiological and chemical characteristics of the water."

- (2) for paragraph 5(3) there is substituted the following paragraph—

"(3) Water distributed to the ultimate consumer in a bottle marked or labelled with the description "spring water" may be transported from the spring to the bottling plant in a container which is not for distribution to the ultimate consumer if, on or before 13 December 1996, water from that spring was so transported.;" and

- (3) for paragraph 8 there is substituted the following paragraph—

**"8.** Both at source and during its marketing, water must be free from—

- (a) parasites and pathogenic micro-organisms;
- (b) *Escherichia coli* and other coliforms and faecal streptococci in any 250 ml sample examined;

- (c) anerobau lleihau-sylffit sborynnol mewn unrhyw sampl 50 ml a archwilar; ac
- (ch)*Pseudomonas aeruginosa* mewn unrhyw sampl 250 ml a archwilar.".
