1. Mae'r Rheoliadau hyn yn diwygio Rheoliadau Arbelydru Bwyd (Cymru) 2009 (O.S. 2009/1795) (Cy.162).

1. These Regulations amend the Food Irradiation (Wales) Regulations 2009 (S.I. 2009/1795) (W.162).

2. Mae'r Rheoliadau hyn yn rhoi effaith i ddarpariaethau—

2. These Regulations give effect to the provisions of—

(a) Penderfyniad y Comisiwn 2010/172/EU sy'n diwygio Penderfyniad 2002/840/EC o ran y rhestr o gyfleusterau a gymeradwywyd mewn trydydd gwledydd ar gyfer arbelydru bwydydd (OJ Rhif L75, 23.3.2010, t.33); a

(a) Commission Decision 2010/172/EU amending Decision 2002/840/EC as regards the list of approved facilities in third countries for the irradiation of foods (OJ No. L75, 23.3.2010, p.33); and

(b) rhestr heb ei dyddio gan y Comisiwn o gyfleusterau a gymeradwywyd ar gyfer trin bwydydd a chynhwysion bwyd ag ymbelydredd ïoneiddio yn yr Aelod-wladwriaethau⁽¹⁾ sy'n disodli rhestr y Comisiwn o gyfleusterau o'r fath ar 3 Medi 2004.

3. These Regulations amend the Food Irradiation (Wales) Regulations 2009 by—

(a) rhoi "risg o bwys" yn lle "risg sylweddol" yn nhestun Cymraeg paragraff 2(i) o Ran 1 (rhoi trwyddedau) o Atodlen 2 (trwyddedau) (*rheoliad 3*);

(a) substituting "risg o bwys" for "risg sylweddol" in the Welsh text of paragraph 2(i) of Part 1 (grant of licences) of Schedule 2 (licences) (*regulation 3*);

(b) yn lle is-baragraff (1)(b) o baragraff 9 o Ran 3 (y gofynion a'r gwaharddiadau sydd i'w dilyn gan drwyddedau) o Atodlen 2 (trwyddedau) rhoi is-baragraff (1)(b) diwygiedig (*rheoliad 4*);

(b) substituting for sub-paragraph (1)(b) of paragraph 9 of Part 3 (requirements and prohibitions to be observed by a licensee) of Schedule 2 (licences) a revised sub-paragraph (1)(b) (*regulation 4*);

Mae Gweinidogion Cymru'n gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd gan adrannau 16(1), 16(3), 17(1), 18(1)(c), 19(1)(b), 26 a 48(1) o Ddeddf Diogelwch Bwyd 1990(1) a pharagraffau 1 a 4(b) o Atodlen 1 iddi, ac a freiniwyd bellach ynddynt hwy(2).

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 16(1), 16(3), 17(1), 18(1)(c), 19(1)(b), 26 and 48(1) of, and paragraphs 1 and 4(b) of Schedule 1 to, the Food Safety Act 1990(1) and now vested in them(2).

In accordance with section 48(4A) of that Act, they have had regard to relevant advice given by the Food Standards Agency.

As required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(1) there has been open and transparent public consultation during the preparation and evaluation of these Regulations.

Title and commencement

1. The title of these Regulations is the Food Irradiation (Wales) (Amendment) Regulations 2010 and come into force on 20 October 2010.

Amendment of the Food Irradiation (Wales) Regulations 2009

2. The Food Irradiation (Wales) Regulations 2009(2) are amended in accordance with regulations 3 to 6.

3. In the Welsh text of Schedule 2 (licences) for the words "risg sylweddol" in paragraph 2(i) of Part 1 there is substituted "risg o bwys".

4. In Schedule 2 (licences) for sub-paragraph (1)(b) of paragraph 9 of Part 3 (requirements and prohibitions to be observed by a licensee)–

(1) in the English text there is substituted the following sub-paragraph–

"(b) its batch number;" and

(2) in the Welsh text there is substituted the following sub-paragraph–

"(b) rhif y swp;".

5. For Schedule 3 (list of approved facilities in member States) there is substituted the Schedule set out in Schedule 1.

6. For Schedule 4 (list of facilities in a country outside the European Community) there is substituted the Schedule set out in Schedule 2.
