## The Local Government (Street Vending and Nuisances) (Amendment) Regulations, 2018

IN EXERCISE of the powers contained in section 84 of the Local Government Act, the following regulations are made:

1. (!) These Regulations may be cited as the Local Government (Street Vending and Nuisances) (Amendment) Regulations, 2018 and shall be read as one with the Local Government (Street Vending and Nuisances) Regulations, 1992, in these Regulations referred to as the principal Regulations.
