Schedules

Definitions

1 In this Regulation,

- (a) “*Dispositions Regulation*” means the *Provincial Parks (Dispositions) Regulation* (AR 241/77);
- (b) “*General Regulation*” means the *Provincial Parks (General) Regulation* (AR 102/85).

La Biche River

2 The Act, the *Dispositions Regulation* and the *General Regulation* apply to the land described in Schedule 1 as if it were a wildland provincial park.

Dillberry Lake

3 Sections 8, 8.1, 8.2, 9, 9.1, 10 and 10.1 of the Act and the *Dispositions Regulation* apply to the land described in Schedule 2 as if it were a park.

Peace River

4 The Act, the *Dispositions Regulation* and the *General Regulation* apply to the land described in Schedule 3 as if it were a wildland provincial park.

Eagle Point

5 The Act, except section 10.1, the *Dispositions Regulation*, except section 60, and the *General Regulation* apply to the land described in Schedule 4 as if it were a park.

Blue Rapids

6 The Act, except section 10.1, the *Dispositions Regulation*, except section 60, and the *General Regulation*, except section 46, apply to the land described in Schedule 5 as if it were a recreation area.

Miquelon Lake

7 The Act, the *Dispositions Regulation* and the *General Regulation* apply to the land described in Schedule 6 as if it were a park.

Aspen Beach

8 The Act, the *Dispositions Regulation* and the *General Regulation* apply to the land described in Schedule 7 as if it were a park.

Dunvegan

9 The Act, the *Dispositions Regulation* and the *General Regulation* apply to the land described in Schedule 8 as if it were a park.

English Bay

10 The Act, the *Dispositions Regulation* and the *General Regulation*, except section 46, apply to the land described in Schedule 9 as if it were a recreation area.

Whitney Lakes

11 The Act, the *Dispositions Regulation* and the *General Regulation* apply to the land described in Schedule 10 as if it were a park.

Repeal

12 The *Section 7 Declaration Regulation* (AR 195/2001) is repealed.

Schedule 1**La Biche River****FIRSTLY:**

All that parcel or tract of land, situate, lying and being in the sixty-eighth (68) township, range seventeen (17), west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

All that portion of the north west quarter of section thirty-three (33) of the said township required for a pipeline right-of-way, as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District at Edmonton as No. 012 1732, containing 1.310 hectares (3.24 acres), more or less.

SECONDLY:

All those parcels or tracts of land, situate, lying and being in the sixty-ninth (69) township, range seventeen (17), west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

All those portions of the west halves of sections four (4) and nine (9), the north half and south west quarter of section sixteen (16) and the east half of section twenty-one (21) of the said township required for the said pipeline right-of-way as shown upon the said plan No. 012 1732, containing 22.789 hectares (56.31 acres), more or less.

The lands herein described contain twenty-four and ninety-nine thousandths (24.099) hectares (59.55 acres), more or less.

Schedule 2**Dillberry Lake**

All those parcels or tracts of land, situate, lying and being in the forty-first (41) township, in range one (1), west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

The south halves of legal subdivisions eleven (11) and twelve (12) of section thirty-three (33) of the said township, containing 16.188 hectares (40.00 acres), more or less.

SAVING AND EXCEPTING:

0.874 hectare (2.16 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office in Edmonton for the North Alberta Land Registration District as No. 1609 C.L.

The lands herein described contain fifteen and three hundred fifteen thousandths (15.315) hectares (37.84 acres), more or less.

Schedule 3

Peace River

All those parcels or tracts of land, situate, lying and being in the eighty-third (83) township, in the twenty-second (22) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

Legal subdivisions twelve (12) and thirteen (13) and all those portions of legal subdivisions eleven (11) and fourteen (14) of section one (1) of the said township, lying generally to the west of the left bank of the Smoky River, containing 42.494 hectares (105.00 acres), more or less.

Schedule 4

Eagle Point

All those parcels or tracts of land, situate, lying and being in the forty-ninth (49) township, range seven (7), west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The north west quarter of section thirteen (13), all those portions of legal subdivisions seven (7), nine (9) and sixteen (16), the north half of legal subdivision two (2), the east half of the south east quarter of legal subdivision six (6), the north half and south west quarter of legal subdivision eight (8), the east half, the east half of the west half and the south west quarter of the south west quarter of legal subdivision ten (10) and the east half of legal subdivision fifteen (15) of section fourteen (14) and the south

half and south half of the north half of legal subdivision one (1) and the east half of the south east quarter of legal subdivision two (2) of section twenty-three (23), covered and not covered by the waters of the North Saskatchewan River and all those portions of the south half of section twenty-four (24) of the said township lying to the south of the right bank of the North Saskatchewan River.

The lands herein described contain two hundred twenty-five and fifty-four thousandths (225.054) hectares (556.12 acres), more or less.

Schedule 5

Blue Rapids

FIRSTLY:

All those parcels or tracts of land, situate, lying and being in the forty-seventh (47) township, in the seventh (7) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

All those portions of the north east quarter, the east half and the east half of the west half of legal subdivision eleven (11) and the south half of the south east quarter of legal subdivision fourteen (14) of section thirty (30), lying generally to the south and east of the right bank of the North Saskatchewan River; all that portion of the north west quarter of section nineteen (19), lying generally to the west of the left bank of the North Saskatchewan River; all those portions of legal subdivision twelve (12), the north west quarter, the north half and the south west quarter of the south west quarter and the north west quarter of the north east quarter of legal subdivision four (4), the north half, the south west quarter and the north half and the south west quarter of the south east quarter of legal subdivision five (5) and the west half of the north west quarter and the north west quarter of the south west quarter of legal subdivision eleven (11) of section thirty (30), legal subdivisions seven (7), eight (8), nine (9) and ten (10), the east half of legal subdivision six (6), the south east quarter of legal subdivision eleven (11), the south half of the south east quarter of legal subdivision fifteen (15) and the south half of the south half of legal subdivision sixteen (16) of section thirty-two (32) and the north half of legal subdivisions five (5) and six (6), the south half and north west quarter of the south west quarter of legal subdivision eleven (11) and the south half, the north west quarter and the south west quarter of the north east quarter of legal subdivision twelve (12) of section thirty-three (33), covered and not covered by the waters of the North Saskatchewan River

and all those portions of the north west quarter of section twenty-nine (29) of the said township lying generally to the south of the right bank of the North Saskatchewan River, to the north and west of the south-easterly limit of a plan boundary as shown upon a map or plan of record in the Department of Environment and Sustainable Resource Development at Edmonton as No. 1663 GEN and to the south and west of the north-easterly limit of a plan boundary as shown upon a map or plan of record in the said Department of Environment and Sustainable Resource Development as No. 14116 TL.

SECONDLY:

All those parcels or tracts of land, situate, lying and being in the partially surveyed forty-seventh (47) township, in the eighth (8) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The south east quarter of section twenty-five (25), legal subdivisions three (3) and four (4) of section twenty-two (22) and all those portions of the north half of section thirteen (13), the south east quarter of section twenty-three (23) and the south half and north east quarter of section twenty-four (24) of the said township, lying generally to the west, north and east of the left bank of the North Saskatchewan River.

THIRDLY:

All those parcels or tracts of land, situate, lying and being in the forty-eighth (48) township, in the seventh (7) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

- (A) All those portions comprised of the island(s) in the north east quarter of legal subdivision fifteen (15) and the north west quarter of legal subdivision sixteen (16) of section four (4), the island(s) in legal subdivisions two (2), six (6) and eleven (11), the west half of the west half of legal subdivision one (1), the south half of legal subdivision seven (7) and the south west quarter, the south half and the north west quarter of the north west quarter and the south west quarter of the south east quarter of legal subdivision fourteen (14) of section nine (9) and all those portions comprised of the island(s), bed and shore in the north west quarter and the west half of the north east quarter of legal subdivision seven (7), the west half, the west half of the south east quarter and the south west

quarter of the north east quarter of legal subdivision ten (10), the north half and the south east quarter of the south east quarter, the south half and the north west quarter of the north east quarter and the north east quarter of the north west quarter of legal subdivision fourteen (14) and the south west quarter of the south west quarter of legal subdivision fifteen (15) of section nine (9) of the said township.

- (B) The island(s) in legal subdivisions five (5), twelve (12), thirteen (13) and fourteen (14), the north west quarter of the north west quarter of legal subdivision three (3), the north half of the north east quarter of legal subdivision four (4), the west half of the west half of legal subdivision six (6), the west half and the north west quarter of the north east quarter of legal subdivision eleven (11) and the west half of the north west quarter of legal subdivision fifteen (15) of section sixteen (16), the island(s) in legal subdivision nine (9) and sixteen (16) of section seventeen (17) and the island(s) in legal subdivisions three (3) and four (4), the west half of the south west quarter of legal subdivision two (2) and the south half of the south half of legal subdivision six (6) of section twenty-one (21) of the said township.
- (C) All those portions of legal subdivision nine (9), the north east quarter of the north east quarter of legal subdivision seven (7), the north half of the north west quarter of legal subdivision eight (8), the north east quarter and the east half of the south east quarter of legal subdivision ten (10), the south east quarter of the south east quarter of legal subdivision fifteen (15) and the south half and the south half of the north east quarter of legal subdivision sixteen (16) of section thirty-four (34) and the west half of legal subdivision twelve (12) and the south west quarter, the west half of the south east quarter, the south west quarter of the north east quarter and the south half of the north west quarter of legal subdivision thirteen (13) of section thirty-five (35) of the said township, covered and not covered by the waters of the North Saskatchewan River.

The lands herein described contain seven hundred sixty-five and two hundred ninety-four thousandths (765.294) hectares (1891.08 acres), more or less.

Schedule 6**Miquelon Lake**

All those parcels or tracts of land, situate, lying and being in the forty-ninth (49) township, range twenty (20), west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

The north west quarter of section thirty-one (31), containing sixty-four and seven hundred five thousandths (64.705) hectares (160 acres), more or less.

SAVING AND EXCEPTING:

Three hundred twenty thousandths (0.320) hectare (0.79 acre) more or less, as required for a surveyed roadway as shown on a plan of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 842 0196.

All that portion of the south west quarter of section thirty-one (31) required for Lot 1, as shown upon a descriptive plan of survey of record at the said Land Titles Office in Edmonton as No. 942 1003, containing fifty-nine and nine hundred thousandths (59.900) hectares (148.02 acres), more or less.

Legal subdivisions nine (9), ten (10) and sixteen (16) of section thirty-one (31), containing forty-eight and six hundred thousandths (48.600) hectares (120 acres), more or less.

SAVING AND EXCEPTING:

Eight hundred nine thousandths (0.809) hectare (2 acres), more or less, described as follows: commencing at the north east corner of the said quarter section; thence southerly along the east boundary thereof 504 feet; thence westerly and parallel to the north boundary of the said quarter section 173 feet; thence northerly and parallel to the said east boundary to intersection with the said north boundary; thence easterly along the said north boundary to the point of commencement.

Legal subdivision fifteen (15) of section thirty-one (31), containing sixteen and two hundred thousandths (16.200) hectares (40 acres), more or less.

SAVING AND EXCEPTING:

Four and fifty thousandths (4.050) hectares (10 acres), more or less, described as follows: the westerly three hundred and thirty (330) feet in uniform width throughout.

All that portion of the north west quarter of section thirty-two (32) required for Lot 1, as shown upon a descriptive plan of survey of record at the said Land Titles Office in Edmonton as No. 952 1159, containing forty-nine and one hundred ninety thousandths (49.190) hectares (121.55 acres), more or less.

The lands herein described contain two hundred thirty-three and four hundred sixteen thousandths (233.416) hectares (576.78 acres), more or less.

Schedule 7**Aspen Beach**

All that parcel or tract of land, situate, lying and being in the fortieth (40) township, range twenty-eight (28), west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

All that portion of the south east quarter of section twenty-one (21) required for Lot 3, Block 2, as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 3634 MC, containing forty-six thousandths (0.046) hectare (0.11 acre), more or less.

Schedule 8**Dunvegan**

All that parcel or tract of land, situate, lying and being in the eightieth (80) township, range four (4), west of the sixth (6) meridian, in the Province of Alberta, Canada, and being composed of:

All that portion of the north west quarter of section eight (8) required for lot one (1) of the Dunvegan Settlement, as shown upon a plan of survey of the said settlement, signed at Ottawa on the 24th day of August, 1910, lying to the north of the northerly limit of a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North

Alberta Land Registration District as No. 1654 L.Z., containing ten and five hundred thousandths (10.500) hectares (25.91 acres), more or less.

Schedule 9

English Bay

All those parcels or tracts of land, situate, lying and being in the sixty-fourth (64) township, range two (2), west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

All those portions of the north west quarter of section twenty-seven (27), the north east quarter of twenty-eight (28) and the north east quarter of section thirty-four (34), not covered by the waters of Cold Lake and all that portion of the south west quarter of section thirty-four (34) lying generally to the south and east of Lake No. 3 as shown upon a plan of survey, signed at Ottawa on the 17th day of January, 1913, and not covered by the waters of Cold Lake.

SAVING AND EXCEPTING:

- (A) Sixty-six thousandths (0.066) hectare (0.16 acre) required for a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 912 0903.
- (B) Two and four hundred fifty-six thousandths (2.456) hectares (6.07 acres) required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 2723 PX.
- (C) Two and seven hundred sixty thousandths (2.760) hectares (6.82 acres) required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 2724 PX.

The lands herein described contain one hundred twenty-eight and thirty thousandths (128.030) hectares (316.37 acres), more or less.

Schedule 10**Whitney Lakes**

All those parcels or tracts of land, situate, lying and being in the fifty-sixth (56) township, in the fourth (4) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

All that portion of the south west quarter of section seventeen (17) required for Lot 2, as shown upon a subdivision plan of survey of record at the Land Titles Office in Edmonton for the North Alberta Land Registration District as 002 1846, containing two and twenty thousandths (2.020) hectares (4.99 acres), more or less.
