1 Name of Regulations [see Note 1]

These Regulations are the *Aboriginal and Torres Strait Islander Heritage Protection Regulations 1984*.

2 Interpretation

In these regulations, *the Act* means the *Aboriginal and Torres Strait Islander Heritage Protection Act 1984*.

3 Identity cards for authorised officers

- (1) An identity card issued for the purposes of subsection 17 (2) of the Act shall be in accordance with the form in Schedule 1.
- (2) For the purposes of paragraph 17 (3) (b) of the Act, the following particulars are prescribed:
 - (a) name of authorized officer;
 - (b) identity card number;
 - (c) date appearing on identity card.

3A Community areas — Victoria

- (1) For the purposes of the definition of *community area* in subsection 21A (1) of the Act, each area specified in Schedule 4, being the area in Victoria of a local Aboriginal community within the meaning of Part IIA of the Act, is declared to be the area of that community for the purposes of that Part.
- (2) While the members of the Aboriginal communities listed in the Schedule to the Act as in force from time to time accept the requirement for the boundaries of their community areas to be described by regulation, the Government of Victoria acknowledges that the boundaries described in the regulations do not necessarily correspond with or represent the traditional tribal boundaries of the Aboriginal people in those communities.

4 Prescribed authority

For the purposes of paragraph 21 (1) (c) of the Act, the Museum of Australia is an authority for safekeeping.

5 Amendment of Schedule to the Act

For the purposes of subsection 21A (2) of the Act, the Schedule to the Act is amended:

- (a) by omitting ‘Cann River Aboriginal Co-operative’;
- (b) by omitting ‘and District’ from ‘Lake Condah and District Co-operative Ltd.’ and substituting ‘Aboriginal’; and
- (c) by omitting ‘West Gippsland Aboriginal Co-operative Ltd.’.

5A Further amendment of Schedule to the Act

For the purposes of subsection 21A (2) of the Act, the Schedule to the Act is further amended:

- (a) by omitting ‘Bendigo Dja Dja Wung’ and substituting ‘Bendigo Dja Dja Wrung’;
- (b) by inserting ‘and’ after ‘Sunraysia’;
- (c) by omitting ‘Lake Tyres’ and substituting ‘Lake Tyers’;
- (d) by inserting ‘West Gippsland Aboriginal Co-operative Ltd.’ after ‘Wathaurong Aboriginal Co-operative Ltd.’.

5B Addition to Schedule to the Act

For the purposes of subsection 21A (2) of the Act, the Schedule to the Act is amended by inserting ‘Brambuk Incorporated’ after ‘Bendigo Dja Dja Wrung Aboriginal Association Incorporated’.

5C Local Aboriginal Community — Yorta Yorta Murray Goulburn Rivers Clans Incorporated

For the purposes of subsection 21A (2) of the Act, the Schedule of the Act is amended by adding at the end ‘Yorta Yorta Murray Goulburn Rivers Clans Incorporated’.

5D Local Aboriginal communities (Act, Schedule)

For subsection 21A (2) of the Act, the Schedule to the Act is amended:

- (a) by omitting the following items:
 - (i) Echuca Aboriginal Co-operative Ltd.;
 - (ii) Healesville and District Aboriginal Co-operative Ltd.;
 - (iii) Sunraysia and District Aboriginal Corporation; and
- (b) by inserting the following items:
 - (i) Coranderrk Koori Co-operative Ltd.;
 - (ii) Mildura Aboriginal Corporation;
 - (iii) Njernda Aboriginal Corporation.

5E Local Aboriginal communities (Act, Schedule)

For subsection 21A (2) of the Act, the Schedule to the Act is amended:

- (a) by omitting the following items:
 - (i) Njernda Aboriginal Corporation;
 - (ii) Shepparton Aboriginal Arts Council Co-operative Ltd.;
 - (iii) Yorta-yorta Cultural Heritage Council Incorporated;
 - (iv) Yorta Yorta Murray Goulburn Rivers Clans Incorporated;
and
- (b) by inserting the following items:
 - (i) Bangerang Cultural Centre Co-operative Ltd.;
 - (ii) North West Nations Clans Aboriginal Corporation;
 - (iii) Taungurung Clans Aboriginal Corporation;
 - (iv) Victorian Boonerwung Elders Land Council Aboriginal Corporation;
 - (v) Yorta Yorta Nation Aboriginal Corporation.

6 Form of emergency declaration

For the purposes of subsection 21C (1) of the Act, the prescribed form of emergency declaration is the form in Schedule 2.

6A Notification of emergency declaration of preservation

- (1) A notification under subsection 21C (4) or (5) of the Act must include:
 - (a) the name and address of each person to whom the notification is to be given; and
 - (b) a statement that the emergency declaration has been made, varied or revoked, as the case requires; and
 - (c) if the notification relates to the making or variation of an emergency declaration:
 - (i) the contents of the declaration or variation; and
 - (ii) a description of the land to which the declaration or the variation relates.
- (2) A notification under subsection 21C (4) or (5) of the Act must be signed by the person giving the notification.

6B Notice of advice or determination

- (1) A notice under paragraph 21D (2) (a) or 21E (2) (a) of the Act must include:
 - (a) the name and address of each person to whom the notice is to be given; and
 - (b) the contents of the advice or determination; and
 - (c) a description of any land to which the advice or determination relates.
- (2) A notice under paragraph 21D (2) (a) or 21E (2) (a) of the Act must be signed by the person giving the notice.

6C Temporary declarations and declarations of preservation

A temporary declaration under paragraph 21D (3) (a) of the Act, and a declaration of preservation under paragraph 21E (3) (a) of the Act, must include:

- (a) the date on which any advice under subsection 21D (1) of the Act in respect of the subject matter of the declaration was received by the Minister; and
- (b) the name of the local Aboriginal community giving the advice; and

- (c) the name of any person nominated by the local Aboriginal community as the community's contact person in respect of the subject matter of the declaration; and
- (d) a description of the place or object in respect of which the determination has been made, including any name or names of the place or object; and
- (e) a concise description of the significance to the local Aboriginal community of the place or object; and
- (f) a detailed description of the land where the place is situated or a description of the place where the object is located; and
- (g) the name and address of the owner or occupier of the land or place; and
- (h) a concise statement of the grounds on which the declaration has been made.

6D Notice of temporary declaration

- (1) A notice under subsection 21D (5) of the Act must include:
 - (a) the name and address of each person to whom the notice is to be given; and
 - (b) a statement that the temporary declaration has been made, varied or revoked, as the case requires; and
 - (c) if the notice relates to the making or variation of a temporary declaration:
 - (i) a statement of the contents of the declaration or variation; and
 - (ii) a description of the land to which the declaration or variation relates.
- (2) A notice under subsection 21D (5) of the Act must be signed by the person giving the notice.

7 Compulsory acquisition

For the purposes of subsection 21L (1) of the Act, the provisions of the *Lands Acquisition Act 1955* in relation to the acquisition of land by compulsory process shall, so far as applicable, apply in relation to:

- (a) Aboriginal places; and

- (b) Aboriginal folklore and Aboriginal objects as if the references in that Act to land were references to any part of that folklore or any of those objects.

8 Prescribed authority: paragraph 21Q (1) (c) of the Act

For the purposes of paragraph 21Q (1) (c) of the Act, the Museum of Victoria is a prescribed authority.

9 Identity card for inspectors

- (1) For the purposes of subsection 21R (2) of the Act, the prescribed form of identity card is the form in Schedule 3.
- (2) For the purposes of paragraph 21R (3) (b) of the Act, the following particulars are prescribed:
 - (a) name of inspector;
 - (b) identity card number;
 - (c) date appearing on identity card.

9A Consent under subsection 21U (4) of the Act

A consent under subsection 21U (4) of the Act must:

- (a) state the name and address of the person to whom the consent is given; and
- (b) describe the area of any land to which the consent relates.

10 Inspection of register

For the purposes of subsection 21V (2) of the Act, the prescribed circumstances in which the register shall be open for inspection are:

- (a) where a person has applied to the Minister in writing to inspect the register and the Minister is satisfied that the person is likely to be affected by a declaration of preservation made under Part IIA of the Act and that disclosure of the particulars in the register to that person would not be likely to frustrate any of the purposes of the Act; or
- (b) where a person has applied to the Minister in writing to inspect the register and the Minister is satisfied that the person has a lawful reason for knowing the particulars in the register and that

disclosure of those particulars to that person would not be likely to frustrate any of the purposes of the Act.

Schedule 4 Community areas in relation to local Aboriginal communities in Victoria

(regulation 3A)

COMMUNITY AREAS IN RELATION TO LOCAL ABORIGINAL COMMUNITIES IN VICTORIA

Notes

1. The community area boundaries described in this Schedule are represented graphically in a computer-based map of the State of Victoria. The map is maintained by the office of the Minister responsible for Aboriginal Affairs (Victoria) in Melbourne. Printed maps may be viewed at that office on written request.
2. In the following descriptions:
 - (a) all references to local government areas and boundaries are to those that existed before 1993, when a major program of local government reform was introduced in Victoria; and
 - (b) 'kms' means kilometres; and
 - (c) all bearings are measured clockwise from true north.

AREA 1: BALLARAT AND DISTRICT ABORIGINAL CO-OPERATIVE LTD.

The boundary of Area 1 begins in Kyneton at the junction of the Calder Highway and Ebdon Street and continues progressively:

- north-westerly along the Calder Highway to its junction in Malmsbury with the Malmsbury-Daylesford Road
- south-westerly along that road to its junction with the Drummond Vaughan Road

-
- generally westerly then northerly along that road through the township of Glenluce to its junction with the Vaughan Springs Road
 - generally westerly and north-westerly along that road through the townships of Vaughan and Yapeen to its junction with the Midland Highway
 - southerly along that highway for approximately 2.5 kms to its junction with the Newstead-Guildford Road in Guildford
 - generally west-north-westerly along that road to its junction with the Daylesford-Newstead Road in Strangways
 - north-westerly along that road to its junction with the Pyrenees Highway in Newstead
 - generally west-north-westerly along that highway to its junction with the Bendigo-Maryborough Road in Maryborough
 - north-north-easterly along that road to its junction with the Maryborough-Dunolly Road in Havelock
 - north-north-westerly along that road through the township of Bet Bet to Dunolly where it becomes the Dunolly-Moliagul Road at its junction with the Bridgewater-Dunolly Road
 - generally north-westerly along the Dunolly-Moliagul Road through the township of Inkerman to its junction with the Bendigo-St Arnaud Road in Moliagul
 - generally north-westerly and then westerly along that road to its junction with the Sunraysia Highway in St Arnaud
 - north-westerly along that highway for approximately 800 metres to its junction with the Wimmera Highway
 - south-westerly along that highway to its junction with the Ararat-St Arnaud Road in Moolerr

-
- generally southerly along that road, through Navarre township, to its junction with the Pyrenees Highway
 - south-westerly along that highway to its junction with the Western Highway in Ararat
 - easterly along that highway for approximately 4 kms to its junction with the Geelong Road
 - south-easterly along that road, past Ballyrogan and across the Eurambeen-Streatham Road, to its junction with the Beaufort-Carranballac Road at approximately E.700720 N.5844120
 - southerly, westerly, south-westerly and again southerly along that road to its junction with the Mount William Road
 - generally south-easterly along that road to its junction with the Skipton Road approximately 1 kilometre north-west of Skipton township
 - south-easterly along that road to the Glenelg Highway
 - easterly along that highway for approximately 1 kilometre to its junction with the Skipton-Rokewood-Geelong Road
 - south-easterly along that road to its junction with the Cressy Road approximately 1.2 kms east of the bridge over the Woody Yaloak River at Pitfield
 - southerly along that road and the Werneth Main Road to Werneth
 - south-easterly along the Cressy-Werneth Road to its junction with the Colac-Ballararat Road
 - generally northerly along that road through Rokewood and Dereel to its junction with the Buninyong Shire-Leigh Shire boundary
 - easterly along that boundary to its junction with the Buninyong Shire-Bannockburn Shire boundary at the Yarrowee River

- easterly along that boundary to its junction with the Meredith-Mt Mercer Road
- southerly and then easterly along that road to its junction with the Midland Highway at Meredith
- northerly along that highway for approximately 0.5 kms to its junction with the Ballan-Meredith Road
- northerly along that road for approximately 0.4 kms to its junction with the Meredith-Durridwarrah Road
- east-north-easterly along that road to its junction with the Geelong-Ballan Road at Durridwarrah
- south-easterly along that road to its junction with the Staughton Vale Road
- northerly along that road to its junction with the Bacchus Marsh-Ballieng Road
- northerly along that road to its junction with the Geelong-Bacchus Marsh Road
- northerly along that road to its junction with the Bacchus Marsh-Gisborne Road
- northerly along that road to its junction with Carrolls Road at Bullengarook
- along that road to its junction with Firth Road
- generally north-westerly along that road and the Trentham-Bullengarook Road to Trentham
- generally south-westerly along the Greendale-Trentham Road to its junction with the Ballan Shire-Kyneton Shire boundary

-
- generally westerly along that boundary to its junction with Daylesford and Glenlyon Shire boundary
 - westerly along that boundary to its junction with the Ballan-Daylesford Road, approximately 1.2 kms south of Leonards Hill
 - northerly along that road to its junction with the Midland Highway in Daylesford
 - north-easterly along that highway for approximately 2.2 kms to its junction with the Malmsbury-Daylesford Road
 - north-easterly along that road to its junction in the township of Denver with the road to Spring Hill
 - generally south-easterly along that road to the settlement of Spring Hill
 - on a direct 58° bearing north-east from the eastern boundary of that settlement to the junction of the Calder Highway and the Redesdale Kyneton Road in Kyneton, to the point where the boundary began.

AREA 1A: BANGERANG CULTURAL CENTRE CO-OPERATIVE LTD

Part A: The boundary of the Bangerang Cultural Centre being Lot 1 of Crown Allotments 79A and 80B, Parish of Shepparton, County of Moira and being the land in Certificate of Title Volume 8910 Folio 987.

Part B: The boundary of Part B of Area 1A begins at the junction of Omeo Creek and the Murray River, approximately 600 metres north of Tom Groggin Station homestead, and continues progressively:

- west-south-westerly to the summit of Mt Pinnibar
- south-south-westerly to the summit of Mt Gibbo

- south-westerly along the Tallangatta Shire-Omeo Shire boundary to its junction with the Omeo Highway, approximately 7 kms north of Sunnyside township
- generally southerly along that highway to its junction with the Bogong High Plains Road, approximately 7.5 kms north of Anglers Rest
- generally westerly then north-westerly along that road to its junction with a line from the summit of Basalt Hill to the summit of Mt Cope at approximately E.525850 N.5914500
- south-westerly along that line to the summit of Mt Cope
- westerly to the summit of Mt Bundara
- west-north-westerly to the summit of Mt Jim
- south-westerly to the summit of Mt Loch
- south-westerly to the summit of Mt Hotham
- south-westerly to the summit of Mt Saint Bernard
- west-south-westerly to the summit of Mt Selwyn
- south-westerly for approximately 300 metres towards the summit of Mt Speculation, to the Mt Selwyn Road at approximately E.490650 N.5900000
- generally northerly along that road to Buckland Junction
- northerly along the Buckland Valley Road to its junction with the Ovens Highway in Porepunkah
- north-westerly along that highway to its junction with the Myrtleford-Yackandandah Road in Myrtleford
- north-easterly along that road to its junction with the Stanley Road
- generally northerly along that road to its junction with the Buckland Gap Road in Beechworth
- southerly along that road to its junction with the Ovens Highway
- westerly along that highway to its junction with the Bowmans-Whorouly Road

-
- south-westerly along that road to Whorouly township
 - southerly along the Carboor-Whorouly Road to its junction with the Bright Road
 - south-easterly along that road to its junction with the continuation of the Carboor-Whorouly Road
 - generally southerly along that road to where it crosses Whorouly Creek at approximately E.461530 N.5947170
 - southerly along that creek to the source of 1 of its upper tributaries at approximately E.461600 N.5945120
 - due south to Gap Creek at approximately E.461620 N.5944470
 - generally southerly along that creek to its junction with Hurdle Creek at Carboor East
 - southerly along that creek for approximately 300 metres to where it is crossed by Wrights Lane
 - southerly, westerly and northerly along that lane to Carboor Upper
 - generally south-westerly along the Carboor Upper Road to its junction with the Moyhu-Meadow Creek Road
 - north-westerly along that road to Moyhu
 - westerly along the Glenrowan-Moyhu Road to its junction with the road to Hansonville
 - southerly then westerly along that road to its junction with the Wangaratta-Kilfeera Road
 - southerly and westerly along that road to its junction with the Benalla-Whitfield Road
 - westerly along that road approximately 200 metres to its junction with the Kilfeera Road
 - generally westerly along that road to its junction with the Benalla-Tatong Road in Benalla
 - north-westerly along that road to its junction with the Benalla-Winton Road

-
- generally north-easterly along that road and the route of the Hume Highway, through the townships of Winton, Glenrowan and Wangaratta, to the junction of the Hume Highway and the Boorhaman-Springhurst Road, approximately 1 kilometre south of Springhurst township
 - westerly along that road for approximately 100 metres, across the North-Eastern Railway, to its junction with an unnamed road that runs north-east through Springhurst township
 - north-easterly along that road to its junction with the Rutherglen-Springhurst Road in Springhurst
 - northerly along that road to its junction with the Chiltern-Rutherglen Road in Rutherglen
 - north-westerly along that road for approximately 150 metres to its junction with the Murray Valley Highway
 - north-westerly along that highway approximately 750 metres to its junction with the Rutherglen-Wahgunyah Road
 - generally north-westerly along that road to the Victoria-New South Wales border on the southern bank of the Murray River at Wahgunyah
 - generally easterly and southerly along that border to the junction of Omeo Creek and the Murray River at the point where the boundary began.

AREA 2: BENDIGO DJA DJA WRUNG ABORIGINAL ASSOCIATION INCORPORATED

The boundary of Area 2 begins at the junction of the Calder Highway and the Donald-Swan Hill Road at Dumosa, and continues progressively:

- generally southerly along the Calder Highway to its junction with the Charlton-St Arnaud Road at Charlton
- southerly along that road to Coonooer
- south-easterly along the Coonooer-Gower-Logan Road to its junction with the Wedderburn Road at Gowar East

-
- south-westerly along that road for approximately 500 metres to its junction with the Carapooee-Gowar East Road
 - generally southerly along that road to its junction with the Bendigo-St Arnaud Road approximately 1 kilometre west of Kooreh
 - generally south-easterly along that road to Moliagul and Dunolly
 - south-south-easterly along the Maryborough-Dunolly Road through the township of Bet Bet to its junction with the Bendigo-Maryborough Road in Havelock
 - south-south-westerly along that road to its junction with the Pyrenees Highway in Maryborough
 - generally east-south-easterly along that highway to its junction with the Daylesford-Newstead Road in Newstead
 - south-easterly along that road to its junction with the Newstead Guildford Road in Strangways
 - generally east-south-easterly along that road to its junction with the Midland Highway in Guildford
 - northerly for 2.5 kms along that highway to its junction with the Vaughan Springs Road
 - generally south-easterly and easterly along that road through the townships of Yapeen and Vaughan to its junction with the Drummond Vaughan Road
 - generally southerly along that road through the settlement of Glenluce and then easterly to its junction with the Malmsbury-Daylesford Road
 - north-easterly along that road to its junction with the Calder Highway in Malmsbury

- generally south-easterly along that highway to its junction with Ebdon Street in Kyneton
- northerly along Ebdon Street, which becomes the Redesdale Road, to its junction with the road to Pipers Creek on the northern boundary of Kyneton township
- easterly along that road to its junction with the Kyneton-Baynton Road
- north-easterly along that road to its junction with the road to Sidonia and the road to Pastoria East
- easterly along the Kyneton-Baynton Road through Pastoria East
- generally north-easterly along that road to Baynton
- generally easterly along the road to Emu Flat
- generally easterly along the road to Pyalong
- easterly along the road to Glenaroua
- generally east-north-easterly along the road to Tallarook to its junction with the road to Hildene, approximately 6.5 kms west of Tallarook
- north-easterly along that road to its junction with the Seymour-Tooborac Road
- easterly along that road to its junction with the Hume Freeway
- southerly along that freeway to its junction with the road from Glenaroua to Tallarook
- south-easterly along that road to its junction with the Upper Goulburn Road in Tallarook
- easterly along that road to its junction with the Goulburn Valley Highway in Trawool township

-
- north-westerly along that highway through Seymour and then northerly to its junction with the Heathcote-Nagambie Road at Nagambie township
 - west-north-westerly along that road for approximately 4 kms to its junction with the Nagambie-Rushworth Road
 - north-north-westerly then westerly along that road to its junction with the Murchison-Goulburn Weir Road
 - generally northerly along that road to Bailieston East township
 - generally northerly and then north-westerly along the Reedy Lake Road to Whroo to its junction with the boundary of the Shire of Goulburn and the Shire of Waranga, approximately 2 kms south south east of Whroo township
 - generally southerly, then south-westerly then westerly along that shire boundary to a point at approximately E.317380 N.5936370
 - due north for approximately 350 metres to a stream that forms the source of Nine Mile Creek
 - generally north-westerly along that creek to its junction with Wanalta Creek
 - north-north-easterly along that creek to where it is crossed by the Bendigo-Murchison Road at Wanalta township
 - westerly along that road to its junction with the Heathcote-Rochester Road
 - northerly along that road to its junction with the Midland Highway
 - westerly along that highway to its junction with the Northern Highway in Elmore
 - north-easterly along that highway for approximately 450 metres to its junction with the Elmore-Raywood Road

- westerly along that road to its junction with the Bendigo-Pyramid Road at Raywood
- northerly along that road to Mitiamo
- north-westerly along the Mitiamo-Kerang Road to where it crosses Bullock Creek at approximately E.246800 N.5992400
- northerly along that creek to a point at approximately E.244860 N.6002150
- north to Sylvaterre Road south of Granite Hill
- westerly and then northerly along that road to its junction with the Pyramid-Leitchville Road
- westerly along that road to its junction with the road to Mincha in Pyramid Hill township
- generally north-westerly along that road to Mincha
- westerly along the Mincha-Canary Island Road to the Loddon Valley Highway at Loddon Vale
- northerly along that highway for approximately 1.5 kms to its junction with the Canary Island-Leaghur Road
- westerly along that road to where it crosses the Loddon River
- northerly along that river to where it is crossed by the Murray Valley Highway after its junction with the Kerang-Quambatook Road, approximately 1 kilometre west of Kerang
- generally south-westerly along that road to Quambatook
