

## **DECREE OF THE PRESIDENT OF AZERBAIJAN REPUBLIC ON APPLYING THE LAW OF AZERBAIJAN REPUBLIC “ON SELECTION ACHIEVEMENTS”**

I decide to provide applying of that law connected with the coming into force of the law of Azerbaijan Republic “On selection achievement”.

1. Ministry of Cabinet of Azerbaijan Republic in a year:

- To prepare offers on making suitable to the Law of Azerbaijan Republic “On selection achievements” of the legislative acts of that is in the force and to present to the President of Azerbaijan Republic.

- To apply making suitability of the normative-judicial acts of the proper central executive power organs and Cabinet of Ministry of the same law and to inform it to the President of Azerbaijan Republic.

2. To charge to the Cabinet of Ministry during two months:

- To prepare projects of legislative acts that determines authority types for breaking the law of Azerbaijan Republic “On selection achievements” and present to the President of Azerbaijan Republic.

- To represent the document (statute) that considered in the second part of the article 15 of the Law of Azerbaijan Republic “On selection achievements” and to inform to the President of Azerbaijan Republic.

- To settle other disputes that created from the Law of “On selection achievements” under his authority.

3. To be defined:

- Authorities of proper executive power organ of Azerbaijan Republic that considered in the article 5 of the Law of Azerbaijan Republic “On selection achievements”;

- Agriculture Ministry of Azerbaijan Republic realizes the authorities of authorized organ that considered in the article 5, in the fifth and seventh parts of article 6, in the first and fourth parts of article 7, in the first, third and fourth parts of article 8, in the first, second and third parts of article 10, in the third and fourth parts of article 11, in the articles 12 and 13, in the third part of the article 14 , in the second part of the article 18, in the first, second and third parts of the article 19, in the fourth paragraph of the article 20, in the second part of 21, in the first part of 22, in the sixth part of the article 23, in the first and second parts of 25, in the first part of 27, in the second part of article 30 and in the first part of the 31.

- Authorities of proper authorized organ that considered in the second part of article 26 of the same Law are realized by Agriculture Ministry of Azerbaijan Republic.

4. To charge to the Agriculture Ministry of Azerbaijan Republic during two months:

- To certify the documents (directions and statutes) that considered in the eleventh part of article 6 , in the first part of article 10 and in the first and third parts of article 11 of the Law of Azerbaijan Republic “On selection achievements” and to inform about it to the President of Azerbaijan Republic.

- To settle other problems that created from the Law of Azerbaijan Republic “On selection achievements” under his authorises.
