Fisheries Act Cap. 391

FISHERIES (MANAGEMENT) REGULATIONS, 1998

The Minister in exercise of the powers conferred on him by section 46 of the *Fisheries Act*, makes the following regulations:

- 1. These regulations may be cited as the Fisheries (Management) Regulations, 1998.
- 2. In these regulations
 - "closed area" means any area declared by the Minister by Notice published in the *Official Gazette* within which the fishing of designated species of fish or by designated fishing methods is prohibited;
 - "closed season" means any period declared by the Minister, by Notice published in the *Official Gazette*, as the period during which fishing of designated species of fish or by designated fishing methods is prohibited;

"ornamental fish" means live fish kept or suitable for keeping in aquaria;

"SCUBA" means self-contained underwater breathing apparatus;

"sea egg" means the white sea urchin Tripneustes ventricosus;

"turtle" means all species of marine turtle.

- 3. The Minister shall designated by Notice published in the Official Gazette
 - (a) fishing methods which are prohibited; and
 - (b) species of fish which may not be harvested during the closed season and in the closed areas.
- 4. No person shall use a trammel or entangling net, or any net that is so hung and deployed as to catch fish primarily by entanglement.
- **5.** (1) No person shall use for fishing
 - (a) a seine net, the smallest mesh of which when stretched is less than 3.81 centimetres, in dimension:
 - (b) a pelagic drift net of a size greater than 2.5 kilometres in length; or
 - (c) a fish trap the mesh of which is less than 3.18 centimetres in dimension.
 - (2) Every fish trap shall be fitted with an escape panel of a size and design approved by the Chief Fisheries Officer.
 - (3) Every fish trap shall be marked for identification in a manner approved by the Chief Fisheries Officer.

- 13. No person shall fish for any ornamental fish or aquatic flora except with the written permission of the Chief Fisheries Officer and in accordance with any condition which he may specify.
- 14. No person shall take, injure, destroy or fish for coral except with the written permission of the Chief Fisheries Officer and in accordance with any conditions which he may specify.
- 15. Any person who contravenes these regulations is guilty of an offence and is liable on summary conviction to a fine not exceeding \$50,000 or to imprisonment for a term of 2 years or to both.
- 16. These regulations shall not apply to any fisheries operations which are conducted solely for the purpose of fisheries research and
 - (a) where permission has been granted in respect of such operations pursuant to section 26 of the Act; and
 - (b) the operations are carried out in accordance with any condition stipulated in the permission.
