MERCHANT SHIPPING AMENDMENT ACT 2019

2019 : 40

WHEREAS the Fifth Schedule to the Merchant Shipping Act 1979 was saved by paragraphs 2 and 3 of Schedule 11 to the Merchant Shipping Act 2002;

AND WHEREAS for ease of reference and for the removal of doubt it is deemed necessary to insert the Fifth Schedule to the Merchant Shipping Act 1979 as Schedule 12 to the Merchant Shipping Act 2002;

Be it enacted by The Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Assembly of Bermuda, and by the authority of the same, as follows:

Citation

1 This Act may be cited as the Merchant Shipping Amendment Act 2019..

Amends section 254

2 Section 254 of the Merchant Shipping Act 2002 (in this Act referred to as "the principal Act") is amended by inserting the following subsection next after subsection (4)—  
“(4A) The Minister may by Order amend Schedule 12.”.

Inserts Schedule 12

3 The principal Act is amended by inserting the Schedule to this Act, as Schedule 12 to the principal Act.

Amends section 255

4 Section 255 of the principal Act is amended by inserting the following subsection next after subsection (3)—

“(3A) Schedule 12, which lists various United Kingdom statutory instruments applicable to Bermuda, has effect.”.

### Validating provisions

5 (1) Any legislation listed in the Fifth Schedule to the Merchant Shipping Act 1979 on the day of the coming into force of the principal Act shall, unless repealed or revoked, or is spent on the day of the coming into force of the this Act, be read and construed as listed in Schedule 12 to the principal Act.

(2) Any reference in the principal Act or any statutory instrument made under the principal Act, to the Fifth Schedule to the Merchant Shipping Act 1979, shall be read and construed as a reference to Schedule 12 to the principal Act.

(3) Any action or decision taken in pursuance of any legislation in the Fifth Schedule to the Merchant Shipping Act 1979 within the period commencing on the day of the coming into force of the principal Act and the day of the coming into force of this Act, is declared to be as valid as it would have been, if this Act had been in force when that action or decision was taken.
