**ACQUISITION OF LAND (COMPULSORY PURCHASE) (FORMS)
REGULATIONS 1971**

*[made under section 25 of the Acquisition of Land Act 1970 [title 19 item 2]
and brought into operation on 13 September 1971]*

4 If—

- (a) within twenty-one days after the service hereof you do not state the particulars of your estate and interest in the land the claims made by you in respect of the land;
- (b) you and I do not agree as to the amount of compensation to be paid by the Government for or in respect of your estate or interest in the land or which you have power to sell or for any damage which may be sustained by you as aforesaid;

I will refer the question of compensation to arbitration under the Act.

5 Without prejudice to the power to refer any question of compensation to arbitration in pursuance of paragraph 4, if no agreement has been reached on the amount of any compensation to be paid in respect of the land, I will, on the expiration of six months after the service hereof, refer the question of disputed compensation to arbitration under the Act.
