**FAUNA CONSERVATION (GENERAL) (AMENDMENT)  
REGULATIONS, 1971**

*(Published on the 12th March, 1971)*

In exercise of the powers conferred by section 93 of the Fauna Conservation Proclamation, 1961 the Minister of Commerce, Industry and Water Affairs has made the following regulations -

Citation           **1.** These regulations may be cited as the Fauna Conservation (General) (Amendment) Regulations, 1971.

Amendment of reg. 3 of S.I. 19/1968   **2.** Regulation 3 of the Fauna Conservation (General) Regulations, 1968 (hereinafter called the principal regulations) is amended by the deletion of the words ---

"Package Licence "B"    K  
Package Licence "C"    L".

Amendment of reg. 4 of the principal regulations   **3.** Regulation 4 of the principal regulations is amended by the deletion of the paragraph headed "A. Game Animals" and the substitution therefor of the following new paragraph ---

"A. Game Animals
