**CONSTITUTION OF BRUNEI DARUSSALAM
(Order under section 83(3))**

EMERGENCY (FOREST RULES) (AMENDMENT) ORDER, 2000

In exercise of the power conferred by subsection (3) of section 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation and commencement.

1. This Order may be cited as the Emergency (Forest Rules) (Amendment) Order, 2000 and shall commence on the same day as the Emergency (Forest Act) (Amendment) Order, 2000.

Amendment of rule 30.

2. Rule 30 of the Forest Rules, in this Order referred to as the Rules, is amended by deleting "Minor penalties" from the marginal note and by substituting "Offences" therefor.

Amendment of rule 31.

3. Rule 31 of the Rules is amended by deleting "Major penalties" from the marginal note and by substituting "Further offences" therefor.

Amendment of Rules.

4. The Rules are amended in the rules specified in the first column of appearing below by deleting the words and figures specified opposite thereto in the second column and by substituting therefor the words and figures specified opposite thereto in the third column.

Rule	Deletion	Substitution

Insertion of new rule 27A.

5. The Rules are amended by inserting the following new rule immediately after rule 27 —

"Third Schedule Fees. 27A. The fees prescribed in the second column of the Third Schedule shall be payable in respect of to the services specified in the first column thereof."
