PROCLAMATION ON
SETTING UP A LIMIT THE FOREST BELONGING
TO THE INLAND AND MARINE FISHERY DOMAIN

The MINISTER OF AGRICULTURE
(see the reference of the Proclamation No.0040 PROR KOR_KOR
SOR KOR)

D E C I D E D

Article1 -The precinct forests defined as the inland and marine fisheries domain and reserved for fishery productivity, specially for aquatic animal spawning ground, are as follow:

- 1-All precinct forests located in the inland fishing lots.
- 2-The precinct forest demarcated as in the map attached (for the surrounding area of the Great Lake)
- 3-All precinct forest at the coastline where sea water is accessible during high tide.

Article2 -The issuing of the land property in the precinct of fishing lot must be approved by the Ministry of Agriculture through the Fisheries Department in advance.

Chopping, clearing, reclaiming or burning the forest as mentioned in the article 1, transportation, stocking or trading fire wood charcoal from the trees of the forest mentioned above and the land expanding for the agriculture or other purpose, in the precinct forest above are prohibit except there are the permission from the Ministry of Agriculture by the proposal of the Fishery Department.

Article3 -Person who chop, clear, reclaim, burn the forest or expand his land which are located in the precinct forest as mentioned in article 1, without permission of the Ministry of Agriculture, is considered as transgressed the article 18 at the point "d", must be condemned by the article 27 of the FIAT_LAW

No.33 KROR CHOR dated on 9 March 1987 (on the Fishery Management and Administration).

Person who transport,stock,trade fire wood-charcoal from the trees of forest mentioned in article 1 ,without permission of Ministry of Agriculture,is considered as transgressed the article 18 at the point "e" ,must be condemned by the article 36 of the FIAT-LAW No. 33 KROR CHOR dated on 9th March 1987(on the Fishery Management and Administration)

If that guilty performance is considered as anobstinancy or caused an acute catastrophe to the fishery resources must be condemned by article 39 of the FIAT-LAW No.33 KROR CHOR dated on 9th March 1987 (on Fishery Management and Administration),in addition.

Article4 All order acts opposing to this proclamation are considered as abolition.

Article5 The committee of the peoples of the province-urban, the Cabinet of the Ministry of Agriculture, the Fishery Department are responsible to execute the proclamation by its respective duties.

Article6 This proclamation has aright full effect from the date of public promulgation.
