Proclamation

on

Establishment of Quality and Processing Division of the Department of Fisheries,
Information and Technology Transfer Office, and Laboratory Office of Inland Fisheries
Research and Development Institute

The Minister of Ministry of Agriculture, Forestry and Fisheries

- Having seen the Constitution of the Kingdom of Cambodia;
- Having seen Royal Decree N° NorSor/RorKorTor/0704/124, dated 15 July 2004, on the appointment of the Royal Government of the Kingdom of Cambodia;
- Having seen Royal Decree N° 02/NorSor/94, dated 20 July 1994, which promulgates the Law on the Organization and Functioning of the Council of Ministers;
- Having seen Royal Krom N° NorSor/RorKorMor/0196/13, dated 24 January, 1996, which promulgates the law on the Establishment of the Ministry of Agriculture, Forestry and Fisheries;
- Having seen the Sub-Decree N° 20 OrNorKror.BorKor, dated 30 April, 1996, on the organization and Functioning of the Ministries and Secretariat
- Having seen Sub-Decree N° 17 OrNorKror.BorKor, dated 07 April 2000 on the Organization and Functioning of the Ministry of Agriculture, Forestry and Fisheries;
- Having seen Sub-Degree N° 105 OrNorKror.BorKor, dated 22 August, 2005, on the additional role of the Ministry of Agriculture, Forestry and Fisheries to formulation of Department of Internal Legislation, Department of Planning and Statistic, Department of International Cooperation, Information Center and Documentation of Agriculture under the Ministry of Agriculture, Forestry and Fisheries.
- Having seen Proclamation N° 1470 BrorKor.KorSorKor, dated 26 March, 1990 on the Organization and Functioning of the Department of Fisheries.

HAS DECIDED

Article 1: The establishment of Quality and Processing Division under the Department of Fisheries, and Information and Technology Transfer Office, and Laboratory Office under Inland Fisheries Research and Development Institute

Article 2: The roles and responsibilities of Quality and Processing Division, Information and Technology Transfer Office and Laboratory Office are as followed:

2.1 Quality and Processing Division

- Research and Develop Technology on Fish and fish Products Processing
- Draft rules and regulation related to Quality, Safety, maintenance of fish and fish products and Monitor Aquatic Animal's Health
- Participate in solving all issues related to quality and safety of fish and fish products at processing and production locations
- Inspect quality and safety of fish and fish products at selling , stocking and processing locations
- Monitor and evaluate quality and safety of fish and fish products base on regional and international standard
- Monitor and evaluate quality of fish and fish products for import and export
- Responsible for other tasks as maybe assigned by the DoF Director General

2.2 Information and Technology Transfer Office

- Collect information and research finding for dissemination
- Manage library, maintenance and set up Fisheries Science Database
- Provide Scientific information to Researcher, Extension worker, Planner and Policy maker
- Provide extension service to Fishermen, Farmers and Investor
- Responsible for other tasks as maybe assigned by the DoF Director General

2.3 Laboratory Office

- Research, analyze, prevent and treat of aquatic animal disease
- Research, analyze, and issue certificate on quality, hygiene and chemical substances in fish and fish Products
- Research and identify aquatic biodiversities
- Responsible for other tasks as maybe assigned by the DoF Director General.

Article 3: Quality and Processing Division of Department of Fisheries, Information and Technology Transfer Office and Laboratory Office of Inland Fisheries Research and Development Institute, lead by one chief and a number of vice-chiefs as assistants.

Article 4: Any decisions or proclamation that contradict to this proclamation shall be considered null and void

Article 5: General Directorate, General Inspectorate, Cabinet Minister, Department of Personnel and Human Resource Development, Director of Department of Agricultural Legislation, Director of the Department of Fisheries, and Chief of all relevant Units shall implement this Proclamation in accordance with their respective duties from the date of signature hereon and forth.
