**FISHERIES (SOUFRIERE/SCOTTS HEAD FISHERIES

2. The area of land described in the Schedule to this Notice is hereby designated as the Soufriere/Scotts Head Fisheries Management Area for the purposes of the Fisheries Act.

**SOUFRIERE/SCOTTS HEAD FISHERIES
MANAGEMENT AREA**

Description of the boundaries of the area of land designated by the Minister as the Soufriere/Scotts Head Fisheries Management Area in the Parish of St. Mark.

All that marine space and substratum and the immediate coastal fringe contained in the Soufriere and Scotts Head Bay extending to Anse Bateau within the area delineated by the following:

(SOUFRIERE/SCOTTS HEAD
FISHERIES MANAGEMENT AREA)

- SOUTH** From a point (A) 15 12.5'N, 61 21.57'W, located due south of the village of Scotts Head 300m from a permanent mooring buoy in the sea in the Atlantic side of the island, the southern-most boundary runs in a straight line for about 400m to another point (H) on the shore perpendicular to point (A).
- WEST** From point (A) the boundary runs westward to another point (B) located at 15 12.67'N, 61 21.57'W, 300m from the base of the back of the tip of Scotts Head. From the point (B) the boundary runs northwards to another point (C) located 15 12.95'N, 61 22.74'W, at sea perpendicular to and due west of the beacon light on the tip of Scotts Head.
- NORTH** From point (C) the boundary runs in a straight line northwards to another point (D) located at 15 13.91'N, 61 22.53'W, about the middle of the Scotts Head Bay, and perpendicular to a point (J) south of the last concrete building on the main road of the Soufriere Village. The boundary continues to run in a straight line northwards to another seaward point (E) located at 15 14.74'N, 61 22.56'W, at Anse Bateau which forms the northern-most extremity of the fisheries management area. From point (E) the northern boundary runs in a straight line to a landward point (F) located at 15 14.76'N, 61 22.47'W, at the base of the seaward cliff.
- EAST** By the Soufriere/Scotts Head Main Road beginning from Anse Bateau and the boundary runs along the top of the ridge that borders the seaward cliff all the way to the village of Soufriere to a point (G) located at 15 13.94'N, 61 21.70'W, at the northern corner of the Old Police Station

and the Soufriere/Scotts Head Main Road. The eastern boundary continues to run southward from point (G) along the Soufriere/Scotts Head Main Road to point (K) located at 15 12.63'N, 61 22.46'W, on the shoreline of the Scotts Head peninsular south of the Scouts Arena. From the point (K) the boundary continues to run along the seaward ridge to point (H) in the South.
