Short title.

STANDARDS ORDER 2007.**2.** (1) The standards listed in section A, B and C of the
Schedule are declared to be compulsory
effective July, 2007.Declaration and purpose
of standards.(2) The purposes of the standards listed in section A of
the Schedule are intended to:

- (a) prevent fraud and deception arising from misleading labeling;
- (b) protect the consumer against danger to health or safety;
- (c) give adequate information to the consumer or user;
- (d) ensure the quality of goods and services.

(3) The purposes of the standard listed in section B of the Schedule are intended to:

- (a) protect the consumer or user against danger to health or safety;
- (b) ensure acceptable quality of foods.

(4) The purposes of the standard listed in section C of the Schedule are intended to:

- (a) protect the consumer or user against danger to health or safety;
 - (b) safeguard the environment.
