PROCLAMATION NO.165/2011

A Proclamation to Amend the Mining Law Proclamation No.68/1995

ARTICLE 1: SHORT TITLE

This Proclamation may be cited as " Mining Law Proclamation No.68/1995 Amendment Proclamation No.165/2011."

ARTICLE 2: STATE PARTICIPATION

Article 41 of the Mining Law Proclamation No.68/1995 is hereby amended as follows:

Without prejudice to the provisions of Article 7 of the Mining Law Proclamation No.68/1995, the Government may acquire, without cost to itself, a participation interest of up to 10 percent of any mining investment. The Government is also entitled to equity participation not exceeding a total of 40 percent, including the 10 percent mentioned hereinabove, the percentage, timing, financing, resulting rights and obligations and other details of which shall be specified by agreement.

ARTICLE 3: EFFECTIVE DATE

This Proclamation shall enter into force as of the date of its publication in the Gazette of Eritrean Laws.
