**The Fishing (Designation of Fisheries) Order, 2009**

**THE COMMERCE AND EMPLOYMENT DEPARTMENT**, in exercise of the powers conferred upon it by section 1(1) of the Fishing (Licensing and Protection of Fisheries) Ordinance, 1987<sup>a</sup>, hereby orders:-

**Revocation of 1991 Order and 2001 Order.**

1. The Fishing (Designation of Fisheries) Order, 1991<sup>b</sup> and the Fishing (Designation of Shellfish Fisheries) Order, 2001<sup>c</sup> are revoked.

**Designated fisheries.**

2. The areas of the seashore set out in the Schedule to this Order are designated as licensed fisheries for the purpose of the Ordinance of 1987, and shall be marked by marker buoys.

**Interpretation.**

3. (1) In this Order, "the Ordinance of 1987" means the Fishing (Licensing and Protection of Fisheries) Ordinance, 1987, and any other expression has the same meaning as in the Ordinance of 1987.

(2) The Interpretation (Guernsey) Law, 1948<sup>d</sup> shall apply to the interpretation of this Order as it applies to the interpretation of an enactment.

**Citation.**

4. This Order may be cited as the Fishing (Designation of Fisheries) Order, 2009.

**Commencement.**

5. This Order shall come into force on the 26th day of March, 2009.

EXPLANATORY NOTE

(This note is not part of the Order)

The purpose of this Order is to prescribe the parts of the foreshore and sea adjacent thereto which have been designated as licensed fisheries under the Ordinance of 1987, and to revoke the two Orders made previously under the Ordinance of 1987.

SCHEDULE

AREAS OF SEASHORE DESIGNATED AS LICENSED FISHERIES

The areas referred to in article 1 are the areas enclosed by imaginary lines joining the intersection of the lines of latitude and longitude (plotted using a Garmin GPS system set to WGS84) set out below. Those imaginary lines are, for the purpose of identification, marked on Digimap GIS aerial photographs endorsed with the words "States of Guernsey - The Fishing (Designation of Fisheries) Order, 2009", signed by the Sea Fisheries Officer on the 24<sup>th</sup> March 2009 and lodged at the Greffe.
