THE ANIMALS AND ANIMAL PRODUCTS (IMPORTATION) ORDER, 1980

The States Committee for Agriculture, in exercise of the powers conferred upon it by subsection (1) of section eleven of the Animals and Animal Products (Import and Export) Ordinance, 1952 as amended (a), hereby orders:-

1. The importation of carcasses into the Island from the Island of Jersey is hereby prohibited.
2. The importation of sheep, goats, swine and all other ruminating animals from the Island of Jersey is prohibited unless, in respect of each consignment thereof, the following conditions are complied with:-
  - (a) there shall have been issued by the Committee a licence in that behalf;
  - (b) the sheep, goats, swine or other ruminating animals shall, on landing in the Island be placed in quarantine for a period of not less than fourteen days in such place and under such conditions as shall be specified by the Committee.
3. Notwithstanding the provisions of section one of this Order carcasses of swine may be imported into the Island from the Island of Jersey, provided they are accompanied by a certificate issued by a Veterinary Surgeon practising in the Island of Jersey certifying that the carcasses were not imported into the Island of Jersey.
4. (1) In this Order, except where the context otherwise requires, the expression "the Committee" means the States Committee for Agriculture and any other expressions have the same meanings as in section fifteen of the Animals and Animal Products (Import and Export) Ordinance, 1952.  
  
(2) Any reference in this Order to any other enactment shall, except where the context otherwise requires, be construed as including a reference to that enactment as amended, repealed or replaced, extended or applied by or under any other enactment including this Order.

5. The Interpretation (Guernsey) Law, 1948 (b), shall apply to the interpretation of this Order as it applies to the interpretation of an enactment.
4. The Animals and Animal Products (Importation) (No. 2) Order, 1958 (c), is hereby repealed.
6. This Order shall come into force on the fifteenth day of December 1980.

Explanatory Note

(This note is not part of the Order, but is intended to indicate its general purport).

The purpose of this Order is to repeal and re-enact certain of the provisions of The Animals and Animal Products (Importation) (No. 2) Order, 1958. This Order prohibits the importation of meat into the Island from the Island of Jersey and also prohibits the importation of sheep, goats, swine and ruminating animals except under the authority of a licence granted by the States Committee for Agriculture.
