THE STATES OF GUERNSEY PUBLIC SERVICES DEPARTMENT, THE STATES OF ALDERNEY GENERAL SERVICES COMMITTEE, and THE CHIEF PLEAS OF SARK SHIPPING COMMITTEE, in exercise of the powers conferred on them by sections 10 and 289 of the Merchant Shipping (Bailiwick of Guernsey) Law, 2002^a, and all other powers enabling them in that behalf, hereby make the following Regulations:-

Amendment of Regulations.

1. (1) The Merchant Shipping (Registration of Ships) (Bailiwick of Guernsey) Regulations, 2009^b are amended as follows.

(2) For Schedule 5, substitute the schedule set out in the Schedule to these regulations.


Citation.
