NOTIFICATION

Port Blair, dated the 19th August, 2005.

No. 153/2005/F.No. 5-1(276)/2002-Dev.I.—In exercise of powers conferred by Section-24 of the A&N Islands Marine Fishing Regulation, 2003 (No. 1 of 2003) read with sub-section (1) of Section 18 thereof, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby makes the following amendment in the Andaman and Nicobar Islands Marine Fishing Rules, 2004 as published in the Andaman and Nicobar Gazette vide Notification No. 103/2004/F.No. 5-1(276)/2002-Dev.I dated 1st June, 2004, namely :-

1. Short Title and Commencement :-

- (a) These rules may be called the Andaman and Nicobar Islands Marine Fishing Rules (amendment) 2005.
- (b) It shall come into force with effect from the date of publication in the official gazette of Andaman and Nicobar Administration.

2. Amendment :-

- (1) In the Andaman and Nicobar Islands Marine Fishing Rules, 2004 (herein after called said Rules) the word "Appellate Authority" appearing in Chapter - VII shall be read as "Appellate Board".
- (2) Rule 8 of the said Rules shall be substituted as under :
 - (a) District Judge appointed by the Andaman and Nicobar Administration shall act as the Chairman of the Appellate Board for the purpose of the Regulation and for the purpose of hearing any matter within the purview of the Regulation. Officer-in-Charge, Fishery Survey of India, Ministry of Agriculture, Govt. of India, Port Blair and Deputy Secretary (Law), Andaman and Nicobar Administration shall act as the Members of the Appellate Board.
 - (b) Assistant Secretary (Fisheries), Andaman and Nicobar Administration shall act as the Secretary to Appellate Board.
 - (c) The Appellate Board shall further be assisted by such other officer of the Andaman and Nicobar Administration / Department of Fisheries as the State Government may, by suitable notification, from time to time, appoint for the purpose.
 - (d) While holding an enquiry or trying any dispute, the Appellate Board shall exercise the power vested on it under Sub section (1), (2) and (3) of Section 20.
 - (e) The fees and allowances to the Chairman, Appellate Board and Members shall be Rs. 500/- and Rs. 300/- respectively per sitting.
