**THE AMENDMENT OF PROVISIONS ON PESTICIDE
REGISTRATION HOLDERS**

THE MINISTER OF AGRICULTURE,

- Considering** :
- a. that decrees of the Minister of Agriculture concerning the registration and licensing of pesticide also stipulate registration holders for the respective pesticide formulas;
 - b. that several pesticide formula owners have submitted applications to transfer their rights and responsibilities as pesticide registration holders to other parties;
 - c. that based on the above matters, it is deemed necessary to amend provisions concerning pesticide registration holders.

H A S D E C I D E D :

To stipulate : **THE DECREE OF THE MINISTER OF AGRICULTURE CONCERNING THE AMENDMENT OF PROVISIONS ON PESTICIDE REGISTRATION HOLDERS.**

Article 1

The registration and licencing of pesticides as contained in column 2 shall be transferred from former registration holders listed in column 3 to new registration holders listed in column 4 in the attachment to this decree.

Article 2

The new registration holders shall assume responsibilities as stipulated in the Decree of the Minister of Agriculture No. 818/Kpts/TP.270/11/90, No. 664/Kpts/TP.270/10/1991, No. 232/Kpts/TP.270/5/1992, No. 638/Kpts/TP.270/10/1993, or No. 494/Kpts/TP.270/6/1994.

Article 3

The position as new registration holders as meant in Article 1 shall be reviewed if the registration holders are no longer appointed to register the pesticide by relevant formula owners or fail to abide by the laws in force.

Article 4

this decree shall come into force as from the date of stipulation.
