

GUIDELINE FOR IMPLEMENTATION OF NATIONAL PROGRAM ON EMPOWERMENT OF INDEPENDENT COMMUNITY OF MARINE AND FISHERY

(Regulation of the Minister of Marine and Fishery of R.I. Number 2/PERMEN-KP/2013, dated February 21, 2013)

WITH THE BLESSING OF THE ONE AND ONLY ONE
MINISTER OF MARINE AND FISHERY
OF THE REPUBLIC OF INDONESIA,

Considering:

- a. in the context of implementing national priority on poverty control through National Program on Empowerment of Independent Community of Marine and Fishery, it is necessary to support the policy in order to achieve improved business capability and welfare, development of marine private business and fishery, and the developing quality of the environmental;
- b. in the context of effective implementation of National Program on Empowerment of Independent Community of Marine and Fishery, it is necessary to prepare Guideline on Implementation of National Program on Empowerment of Independent Community of Marine and Fishery;
- c. based on the consideration referred to in letter a and letter b, it is necessary to stipulate Regulation of the Minister of Marine and Fishery on Guideline

for Implementation of National Program on Empowerment of Independent Community of Marine and Fishery;

DECIDES :

To stipulate:

REGULATION OF THE MINISTER OF MARINE AND FISHERY ON GUIDELINE FOR IMPLEMENTATION OF NATIONAL PROGRAM ON EMPOWERMENT OF INDEPENDENT COMMUNITY OF MARINE AND FISHERY.

Article 1

The Guideline for Implementation of National Program on Empowerment of Independent Community of Marine and Fishery is intended to constitute as guideline for implementation of development activ-

ity of Rural Mina (PIMP) business, empowerment of People Salt Business (PUGAR), and development of Steadfast Coastal Urban (PDPT).

Article 2

The Guideline for Implementation of National Program on Empowerment of Independent Community of Marine and Fishery as specified in the Attachment constituting inseparable part of this Regulation of the Minister.

Article 3

Details on the implementation and development of National Program on Empowerment of Independent Community of Marine and Fishery will be clarified in Technical Guideline by the Director General relating to the scope of the Ministry of Marine and Fishery by referring to this Regulation of the Minister and in the implementation thereof and must be reported in writing to the Minister through the Secretary General.

Article 4

This Regulation of the Minister comes to force on the date it is enacted.

For public cognizance, this Regulation of the Minister shall be announced by placing it in the State Gazette of the Republic of Indonesia.
