

THE EXTENSION OF EXPORT APPROVAL OF MINING PRODUCTS

(Circular of the Director General of Foreign Trade Number 04/M-DAG/ED/12/2013 dated December 9, 2013)

THE MINISTER OF TRADE OF
THE REPUBLIC OF INDONESIA

To Companies Holding Registered Exporter of Mining Products (ET-Mining Products) and already securing Export Approval of Mining Products (SPE-Mining Products),

Observing:

1. Law Number 4 Year 2009 on and Mineral and Coal Mining;
2. Regulation of the Minister of Trade Number 29/M-DAG/PER/5/2012 concerning Provisions on the Export of Mining Products as already amended by Regulation of the Minister of Trade Number 52/M-DAG/PER/8/2012;
3. Circular of the Minister of Energy and Mineral Resources No. 04 E/30/MEM/2013 dated August 28, 2013 on the Implementation of Export Policy on Mining Products in the framework of economic stabilization and growth,

We hereby inform that:

1. The export of mining products in the form of raw materials/ores is effective up to January 12, 2014.

2. Holders of ET-Mining Products already securing SPE of Mining Products are given opportunity to extend the realization of the export of mining products in the form of raw materials/ores up to January 11, 2014 with the provision as follows:

- a. SPE-Mining Products expired on December 31, 2013 and still have the rest of allocation of mining products in the form of raw materials which have not been exported up to December 13, 2013.
- b. Submitting application for the extension of SPE-Mining Products to the Director General of Foreign Trade, Ministry of Trade through Trade Service Unit (UPP) by enclosing: 1) Detail of the quality and quantity of the remaining allocation of the would-be exported mining products; 2) Timetable of the shipment and destination country; 3) Copy of Controlling Card; and 4) Copy of SPE-Mining Products.
- c. The application for the extension of SPE-Mining products is received in no later than December 20, 2013.
- d. The export of mining products continues to abide by the provision of technical verification or inquiry.

GOVERNMENT REGULATIONS

3. The allocation of SPE-Mining Products may be supplemented by enclosing recommendation from the Director General of Minerals and Coal, Ministry of Energy and Mineral Resources.
