

STIPULATION OF THE PURCHASING PRICE OF FARMER SOYBEAN IN THE FRAMEWORK OF SOYBEAN PRICE STABILIZATION PROGRAM (Regulation of the Minister of Trade Number 25/M-DAG/PER/6/2013 dated June 13, 2013)

Considering:

- a. in order to implement the provision of Article 8 of Regulation of the Minister of Trade Number 23/M-DAG/PER/5/2013 on Soybean Price Stabilization Program, it's necessary to stipulate the purchasing price of farmer soybean;
- b. having regards to letter a, it is necessary to stipulate a regulation of the Minister of Trade on Stipulation of the Purchasing Price of Farmer Soybean in the Framework of Soybean Price Stabilization Program;

DE C I D E S :

To stipulate:

STIPULATION OF THE PURCHASING PRICE OF FARMER SOYBEAN IN THE FRAMEWORK OF SOYBEAN PRICE STABILIZATION PROGRAM

Article 1

Referred to in this ministerial regulation as:

1. Soybean shall be a result of soybean plant i (Glycine max. Merr) in the form of yellow dry kernel already released from pod and cleaned, classified into Tariff Heading / HS 1201.90.00.00.
2. The purchasing price of farmer soybean hereinafter called HBP Soybean shall be a reference price for the purchase of soybean at the farmer level in the framework of the soybean price stabilization program.

3. Minister shall be the minister in charge of public administration in the field of trade.

Article 2

HBP Soybean shall be set at Rp 7,000/kg (seven thousand rupiah per per kilogram).

Article 3

HBP Soybean as meant in Article 2 shall apply to the great harvest period of the third quarter, from July 1 to September 30,2013.

Article 4

IN the case of the validity period of HBP Soybean on the basis of this ministerial already expiring and the new one not yet being stipulated, HBP Soybean in this ministerial regulation shall continue to apply.

Article 5

The ministerial regulation shall come into as from July 1,2013.

For public cognizance, the ministerial regulation shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
