**THE COMMISSION OF THRESHOLDS OF MICROBIAL AND RESIDUAL
CONTAMINATION IN ANIMAL BASED FOODSTUFFS**

THE MINISTER OF AGRICULTURE,

- Considering :**
- a. that with the increasing use of medicines for animals and within the framework of protecting the health of society consuming animal based foodstuffs from the hazard of microbial and residual contamination, it is necessary to conduct control through the analysis and study of the animal based materials from the aspect of the hazard of microbial and residual contamination;
 - b. that the analysis and study as meant in point a, which is conducted by the Team for the formulation of thresholds of microbial and residual contamination based on the Decree of the Minister of Agriculture No. 91/Kpts/KP.150/2/93, in connection with organisational changes need to be adjusted to current developments;

- c. that with account taken of the above matter, it is deemed necessary to set up a commission of thresholds of microbial and residual contamination in animal based foodstuffs.

HAS DECIDED :

To stipulate : **THE DECREE OF THE MINISTER OF AGRICULTURE CONCERNING THE COMMISSION OF THRESHOLDS OF MICROBIAL AND RESIDUAL CONTAMINATION IN ANIMAL BASED FOODSTUFFS.**

FIRSTLY : To establish the Commission of Thresholds of Microbial and Residual Contamination in Animal Based Foodstuffs, with the composition of membership as contained in the attachment to this decree.

SECONDLY : The Commission as meant in the First dictum shall have the task of giving suggestions and considerations to the Minister of Agriculture through the Director General of Animal Husbandry, within the framework of :

1. gathering material/information connected with microbial and residual contamination in animal based foodstuffs;
2. processing information on microbial contamination and residual contents of biological materials, chemical materials, heavy metals, antibiotics, hormones and other drugs in animal based foodstuffs;
3. formulating concepts of thresholds of microbial and residual contamination in animal based foodstuffs covering microbial contamination and residual contents of biological materials, chemical materials, heavy metals, antibiotics hormones and other drugs in animal based foodstuffs.

- THIRDLY** : In executing the task the Commission shall be responsible and submit quarterly reports to the Minister of Agriculture through the Director General of Animal Husbandry.
- FOURTHLY** : If considered necessary, the Chairman of the Commission can set up working groups to assist the commission.
- FIFTHLY** : All costs required for the implementation of this decree shall be borne by the budget of the Directorate General of Animal Husbandry.
- SIXTHLY** : With the enforcement of this decree, the Decree of the Minister of Agriculture No. 91/Kpts/KP.150/2/93 on the formation of the Team for formulation of thresholds of microbial and residual contamination in animal based foodstuffs, shall be declared null and void.
- SEVENTHLY** : This decree shall come into force as from the date of stipulation.
