THE MINISTER OF MARINE AFFAIRS AND FISHERIES REPUBLIC OF INDONESIA,

Considering : a. that in the context of smooth implementation of the duties of
Coordination forum for Criminal Action Handling, requires to amend the
Regulation of Minister of Marine Affairs and Fisheries Number
PER.13/MEN/2005 Concerning Coordination Forum for Criminal Action
Handling in Fisheries Sector, as amended by the Ministerial Regulation of
Marine Affairs and Fisheries Sector Number PER.11/MEN/2006;

b. that for this purpose, it is necessary to establish the Regulation of
Minister of Marine Affairs and Fisheries Concerning Second
Amendment of Minister of Marine Affairs and Fisheries Number
PER.13/MEN/2005 Concerning Coordination Forum for Criminal
Action Handling;

DECIDE:

To stipulate : MINISTERIAL REGULATION OF MARINE AFFAIRS AND FISHERIES CONCERNING SECOND AMENDMENT OF MINISTERIAL REGULATION OF MARINE AFFAIRS AND FISHERIES NUMBER PER.13/MEN/2005 CONCERNING COORDINATION FORUM FOR CRIMINAL ACTION HANDLING IN FISHERIES SECTOR.

Article I

Several Provisions in Ministerial Regulation of Marine Affairs and Fisheries Number PER.13/MEN/2005 Concerning Coordination Forum for Criminal Action Handling in Fisheries Sector, as amended by Ministerial Regulation of Marine Affairs and Fisheries Number PER.11/MEN/2006, are subject to the following amendments:

1. The Provisions of Article 4 are amended to read as follows:

Article 4

Organizational Structure of Coordination Forum for Criminal Action Handling in Fisheries Sector are consists of:

- a. Chairman : Minister of Marine Affairs and Fisheries
- b. Deputy Chairman I : Head of the Republic of Indonesia National Police

c. Deputy

- c. Deputy Chairman II : Head Staff of The Indonesian Navy.
- d. Secretary I, concurrently member : Director General of Supervision of Marine Resources and Fisheries, Ministry of Marine Affairs and Fisheries
- e. Secretary II, concurrently member : Head of the Criminal Investigation Agency, National Police of the Republic of Indonesia
- f. Members :
 - 1. Solicitor General for Special Criminal Sector, Attorney General Office;
 - 2. Operational Assistant of the Head Staff of Indonesian Navy;
 - 3. Director General of Immigration, Ministry of Law and Human Rights;
 - 4. Director General of Marine Transportation, Ministry of Transportation;
 - 5. Director General of Customs and Excise, Ministry of Finance;
 - 6. Director General of Manpower Supervision Development, Ministry of Manpower and Transmigration;
 - 7. Director General of Protocol and Consular Affairs, Ministry of Foreign Affairs;
 - 8. Director of Regulation and Procedures for Criminal Cases, Supreme Court;
 - 9. Director of Aquatic Police, Security Maintenance Agency, the Indonesian National Police.

2. The provisions of Article 8 are amended to read as follows:

Article 8

- (1) Any required budget in implementing the duties of Coordination Forum for Criminal Action Handling in Fisheries Sector are charged to the State Revenue and Expenditure Budget of the Ministry of Marine Affairs and Fisheries.
- (2) Any required budget in implementing the duties of Coordination Forum for Criminal Action Handling in Fisheries Sector are charged to the Provincial or District/City Regional Revenue and Expenditure Budget in accordance with their authority.

This Ministerial Regulation comes into force as from the date of stipulation.
