**STIPULATION ON THE PRIORITY OF PROVINCES/FIRST-LEVEL  
REGIONS FOR THE PROGRAMME OF SUSTAINABLE COASTAL AREAS**

**THE MINISTER OF ENVIROMENTAL AFFAIRS**

**Considering** : that in the framework of further enforcing Decree of the State Minister of Environmental Affairs No: KEP-45/MENLH/11/1996 on the Programme of Sustainable Coastal Areas, it is necessary to stipulate a decree of the State Minister of Enviromental Affairs.

**Bearing  
in mind** :

1. Law No. 5/1974 on the principles of administration in regions (State Gazette No. 38/1974, Supplement to State Gazette No. 3037);
2. Law No. 4/1982 on the basic stipulations on enviromental management (State Gazette No. 12/1982, Supplement to State Gazette No. 3215);
3. Presidential Decree No. 44/1993 on the position, main tasks, functions, organizational structure and working system of state ministers;

4. Presidential Decree No. 77/1994 on the Agency on the Control of Environmental Impacts;
5. Decree of the State Minister of Environmental Affairs No. KEP-45/MENLH/11/1996 on the Programme of Sustainable Coastal Areas.

**Observing :**

1. The result of 1st national coordination meeting on environmental management and sustainable development in 1994 in Jakarta on November 22-24, 1994;
2. Summary of the Annual Objectives of the Five-Year Development Plan, 1994/95-1998/99;
3. The result of the meeting on the discussion of the plan for the working programme of sustainable coastal areas in Jakarta on October 2, 1996.

**HAS DECIDED**

**To stipulate :**

**FIRSTLY :**

**A DECREE OF THE MINISTER OF ENVIRONMENTAL AFFAIRS ON THE STIPULATION ON THE PRIORITY OF PROVINCES/FIRST-LEVEL REGIONS FOR THE PROGRAMME OF SUSTAINABLE COASTAL AREAS.**

**SECONDLY :**

To stipulate the priority of provinces/first-level regions for the Programme of Sustainable Coastal Areas which shall cover the provinces/first-level regions of :

1. Special Region of Aceh;
2. North Sumatera;
3. West Sumatera;
4. Riau;
5. South Sumatera;
6. Lampung;
7. Special Region of Capital City of Jakarta;
8. West Java;
9. Central Java;
10. East Java;
11. Bali;
12. West Nusa Tenggara;
13. South Kalimantan;
14. Maluku;
15. North Sulawesi;
16. Central Sulawesi;
17. South Sulawesi;

**THIRDLY :**

The provinces/first-level regions as meant in the SECOND dictum shall carry out their activities with the following as the guidelines:

- a. The Programme of Sustainable Coastal Areas;
- b. The Directive, guideline and procedure for the implementation of the Programme of Sustainable Coastal Areas stipulated by the Technical Team for the Programme of Sustainable Coastal Areas;
- c. Other directives linked with efforts to implement the Programme of Sustainable Coastal Areas Stipulated by the Minister of Home Affairs.

**FOURTHLY :**

All expenses arising in connection with the activities of the Programme of Sustainable Coastal Areas in the regions shall be borne by the Budget of revenues and expenditures of the regions concerned.

**FIFTHLY :**

This decree shall take effect as from the date of stipulation.
