

**DECREE OF THE MINISTER OF FORESTRY
NO. 593/KPTS-II/1996; DATED: SEPTEMBER 16, 1996**

HUNTING LOCATIONS IN HUNTING AREAS

THE MINISTER OF FORESTRY,

Considering: a. that by Government Regulation No. 13 of 1994, Provisions have been laid down concerning the game hunting;
b. that in order to further carry out the provision in Article 6 paragraph (2) of Government Regulation No. 13 of 1994 as meant in point a. it is deemed necessary to stipulate the provisions concerning hunting locations in hunting areas in a decree of the Minister of Forestry.

HAS DECIDED

**To Stipulate: THE DECREE OF THE MINISTER OF FORESTRY CONCERNING
HUNTING LOCATIONS IN HUNTING AREAS.**

Article 1

Hereinafter referred to as:

1. Hunting areas shall be areas outside hunting parks and hunting gardens where game can be found for hunting activities.
2. Hunting locations shall be places in hunting areas where hunting activities can be carried out for certain periods.

Article 2

- (1) Hunting areas can be designated within forest zones, and can be outside forest zones.
- (2) Forest zone which can be designated as hunting areas shall comprise:
 - a. protected forest zones;
 - b. production forest zones.
- (3) Non forest zone which can be designated as hunting areas shall comprise:
 - a. free land belonging to the state.
 - b. land bearing certain titles on the basis of the Agrarian Act.

Article 3

- (1) Hunting locations in hunting areas situated within forest zones as meant in Article paragraph (2) shall be designated by Heads of Regional Offices of the Ministry of forestry in relevant provinces for certain periods on the basis of proposals from Heads of local centers/sub centres of Natural Resources Conservation (KSDA).
- (2) Hunting locations in hunting areas situated outside forest zones as meant Article 2 paragraph (3) shall be designated by Regents/Mayors/Heads of relevant second level regions for certain periods on the basis of proposals from Heads of local Centres/sub centres of natural resources Conservation (KSDA).

Article 4

Proposal for hunting locations within forest zones as meant in Article 3 paragraph (1) shall enclose:

- a. Maps of locations at the scale of 1: 10.000;
- b. Game inventory results;
- c. Considerations made by agencies managing relevant forest zones; .
- d. Data on expanse limits of hunting locations;
- e. Names of hunting locations.

Article 5

- (1) Proposals for hunting locations outside forest zones as meant in Article 3 paragraph (2) shall enclose:
 - a. considerations made by local Centres of KSDA;
 - b. maps of locations at the scale of 1: 10.000;
 - c. considerations made by companies or owners of relevant zones;
 - d. expanse limits of hunting locations;
 - e. names of hunting locations.
- (2) Regents/Mayor/Heads of relevant second level regions shall announce the positions of hunting locations in non forest zones, already designated.

Article 6

- (1) Hunting activities in hunting locations situated within zones with certain titles under the Agrarian Act shall be in compliance with the activities of management of the zones designated as hunting locations.
- (2) The realisation of hunting activities as meant in paragraph (1) shall be jointly regulated by the personnel responsible for hunting activities and holders of land titles.

Article 7

- (1) The designated of hunting locations shall be adjusted to expanse limits of hunting areas, numbers and species of wild animals as well as types of hunting equipment to be used.
- (2) The designated of hunting locations as meant in paragraph (1) shall he followed by the fixing of signs indicating:
 - a. names of hunting locations;
 - b. expanse limits of hunting locations;
 - c. timetables for hunting activities.

Article .8

Technical provisions concerning the designation of hunting locations shall be further stipulated by the Director General of Forest Protection and Nature Conservation.

Article 9

This decree shall come into tierce as from the date of stipulation.
