THE DEPRECIATION OF REMAINDER OF UNUSED EXCISE TAPES

THE MINISTER OF FINANCE,

- Considering :
- a. that with the stipulation of new excise tariffs and floor prices of tobacco products as well as retail selling prices of tobacco products, a quantity of old excise tapes are left and no longer used, which are stored at the excise tape warehouse of the Office of the Directorate General of Customs and Excise;
 - b. that the remainder of unused excise tapes are of no benefit, so that it is deemed necessary to depreciate them from the list of state assets by means of destruction, which shall be stipulated in a Decree of the Minister of Finance.
- Bearing in mind :
- 1. Act No. 11/1995 on excise affairs (State Gazette of 1995 No. 76, Supplement to State Gazette No. 3613);
 - 2. Presidential Decree No. 122/M/1998;

3. The Decree of the Minister of Finance No. 118/KMK.05/1998 dated on the stipulation of excise tariffs and floor prices of tobacco products.

HAS DECIDED :

To stipulate : **THE DECREE OF THE MINISTER OF FINANCE CONCERNING THE DEPRECIATION OF REMAINDER OF UNUSED EXCISE TAPES.**

FIRSTLY : To depreciate the remainder of unused excise tapes from the movable assets of the state stored at the Head Office of the Directorate General of Customs and Excise (DJBC) in the quantity as specified in the attachment to this decree by means of destruction.

SECONDLY : The procedure for depreciation and destruction as meant in the *First dictum* shall be in accordance with the provisions in the relevant acts in force.

THIRDLY : The Director General of Customs and Excise shall further regulate the implementation of this decree.

FOURTHLY : This decree shall come into force as of the date of stipulation.
