THE REGISTRATION OF PESTICIDES FOR EXPORTS

THE MINISTER OF AGRICULTURE,

- Considering** :
- a. that several countries indicated their interest to import pesticides registered in Indonesia under certain requirements;
 - b. that based on evaluation of applications for the registration of pesticides submitted, the relevant pesticides have fulfilled the specific requirements laid down for exports;
 - c. that in connection with the above matters, it is deemed necessary to register pesticides for exports.

Taking

into account : The opinion of the Chairman of the Pesticide Commission in the letter No. 416/Kompes/99 dated August 20, 1999.

HAS DECIDED :

To stipulate : THE DECREE OF THE MINISTER OF AGRICULTURE CONCERNING THE REGISTRATION OF PESTICIDES FOR EXPORTS.

Article 1

- (1) The pesticides as contained in column 2, which are registered with registration numbers as listed in column 5 in the names of registration holders as contained in column 4 of the attachment to this decree shall only be used for export purposes and may not be domestically distributed and applied.
- (2) The pesticides as referred to in sub-section (1), according to data and information provided in relevant applications for registration, shall contain active substances and take their formula forms as listed in column 2 and column 3 of the attachment to this decree.

Article 2

- (1) The registration as meant in Article 1 shall be valid for a period of 5 (five) years and extendable.
- (2) Registration of the pesticides as meant in Article 1 shall be applied for in writing before the termination of the period as stipulated in sub-section (1).

Article 3

The registration holders as meant in Article 1 sub-section (1) shall be obligated :

- a. to guarantee the quality of pesticides according to data and information provided in relevant applications for registration;
- b. to guarantee the containers, packages and labels of pesticides pursuant to the Decree of the Minister of Agriculture No. 429/Kpts/Um/9/1973 and/or other provisions in force;
- c. to submit annual reports on the realisation of their pesticide exports to the Minister of Agriculture through the Pesticide Commission.

Article 4

For some purposes as requested by importers, the Minister of Agriculture can consider changing the names, containers and labels of pesticides as meant in Article 1 sub-section (1).

Article 5

The registration as meant in Article 1 sub-section (1) shall be revoked if :

- a. the relevant pesticides are no longer in conformity with the data and information in their applications for registration;
- b. the relevant pesticides prove to possess previously unknown potential, which is hazardous to human health and the environment;
- c. The relevant pesticides are distributed and/or used domestically, and/or violations of the acts in force are committed;
- d. the registration holders fail to submit reports on the realisation of their pesticide exports for 2 (two) years in succession.

Article 6

This decree shall come into force as from the date of stipulation.
