THE STIPULATION OF TARIFFS OF IMPORT DUTY ON RICE AND SUGAR

THE MINISTER OF FINANCE,

Considering : that in order to maintain interests of farmers and consumers in the framework of stabilisation of domestic food procurement, it is deemed necessary to stipulate tariffs of import duty on rice and sugar;

Bearing in mind :

1. Act No. 10 of 1995 on customs affairs (State Gazette of 1995 No. 75, Supplement to State Gazette No. 3612);
2. Presidential Decree No. 355/M/1999;
3. Decree of the Minister of Finance No. 440/KMK.05/1996 on the stipulation of systems of classifications of goods and tariffs of import duty on imported goods as already amended and supplemented the latest by the Decree of the Minister of Finance No. 505/KMK.01/1999.

Observing :

1. Letter of the Minister of Agriculture No. KU.410/449 /Mentan/XII/99 dated December 20, 1999;
2. Letter of the Minister of Industry and Trade No. 1015/MPP/12/1999 dated December 22, 1999.

HAS DECIDED :

To stipulate : **THE DECREE OF THE MINISTER OF FINANCE ON THE STIPULATION OF TARIFFS OF IMPORT DUTY ON RICE AND SUGAR.**

Article 1

The import of rice and sugar shall be subjected to import duty with tariffs as stipulated in the Attachment to this decree.

Article 2

The provision in this decree shall be effective for the import of goods whose Import Declarations (PIB) have already secured registry numbers from Inspection Offices of the Directorate General of Customs and Excise in importing seaports as from the date of enforcement of this decree.

Article 3

With the enforcement of this decree, the provisions on the imposition of tariffs of import duty already existing before the stipulation of this decree shall be declared null and void as far as they concern the goods as meant in Article 1.

Article 4

The Director General of Customs and Excise shall be instructed to implement the provision in this Decree.

Article 5

This decree shall come into force as from January 1, 2000.
For public cognizance, this decree shall be published by placing it in State Gazette.
