**THE AMENDMENT TO THE DECREE OF THE MINISTER OF FORESTRY
 NUMBER 38/KPTS-II/1996 ON THE GRANTING OF TIMBER ESTATE FOREST EXPLOITATION
 RIGHT ON AN AREA WITH AN EXTENT OF \pm 296,400 (TWO HUNDRED
 NINETY SIX THOUSAND FOUR HUNDRED) HECTARES WHICH IS LOCATED IN THE SOUTH
 SUMATERA PROVINCE TO PT MUSI HUTAN PERSADA**

THE MINISTER OF FORESTRY,

- Considering** :
- a. that on the basis of the Decree of the Minister of Forestry Number 38/KPTS-II/1996 dated January 29, 1996 to PT MUSI HUTAN PERSADA has been granted the Timber Estate Forest Exploitation Right on an area with an extent of \pm 296,400 (two hundred ninety six thousand four hundred) hectares which is located in the South Sumatera Province.
 - b. that on March 2, 2000 a joint agreement has been reached between the Department of Forestry and Plantations, the Regional Administration of the South Sumatera Province, PT MUSI HUTAN PERSADA, and the Village Members ex Marga Rembang Kapak Tengah I, Rembang Lubai District, Muara Enim Regency, which in essence declares that the forest area with an extent of \pm 12,050

(twelve thousand fifty) hectares as illustrated in the attachment to this Decree is removed from the area of the Timber Estate Forest Exploitation Right of PT MUSI HUTAN PERSADA to be delivered to the Regional Administration of the South Sumatera Province.

- c. that in connection with the matters mentioned above, it is considered necessary to amend the Decree of the Minister of Forestry Number 38/Kpts-II/1996 dated January 29, 1996 insofar as it concerns the extent of the area of the Timber Estate Forest Exploitation Right of PT MUSI HUTAN PERSADA, with a Decree of the Minister of Forestry and Plantations.

Attention to : The Joint Agreement dated March 2, 2000 between the Department of Forestry and Plantations, the Regional Administration of the South Sumatera Province, PT MUSI HUTAN PERSADA, and Village Members ex Marga Rambang Kapak Tengah I, Rambang Lubai District, Muara Enim Regency.

HAS DECIDED :

To lay down : **THE AMENDMENT TO THE DECREE OF THE MINISTER OF FORESTRY NUMBER 38/KPTS-II/1996 ON THE GRANTING OF TIMBER ESTATE FOREST EXPLOITATION RIGHT ON AN AREA WITH AN EXTENT OF \pm 296,400 (TWO HUNDRED NINETY SIX THOUSAND FOUR HUNDRED) HECTARES WHICH IS LOCATED IN THE SOUTH SUMATERA PROVINCE TO PT MUSI HUTAN PERSADA.**

Article I

1. To change the extent of the working area of the Timber Estate Forest Exploitation Right of PT MUSI HUTAN PERSADA which is mentioned in the Decree of the Minister of Forestry Number 38/ Kpts-II/1996 dated January 29, 1996 the Attachment to the Decree and the working area map, which was initially :

with an extent of \pm 296,400 (two hundred ninety six thousand four hundred) hectares;

to become :

with an extent of \pm 284,350 (two hundred eighty four thousand three hundred fifty) hectares.

2. To add a new provision :

The reduction of the area to an extent of \pm 12,050 (twelve thousand and fifty) hectares which management would subsequently be transferred to the Regional Administration of the South Sumatera Province constitutes a commitment of the Government to improve the prosperity of the community within and around the working area of PT MUSI HUTAN PERSADA in general and the Village Members ex Marga Rambang Kapak Tengah I.

Article II

1. With the issuance of this Decree, the Decree of the Minister of Forestry Number 38/Kpts-II/1996 dated January 29, 1996 remains in force, insofar as no changes are made according to this Decree.
2. This Decree comes into force on the date it is laid down.
