DECREE OF THE MINISTER OF MINES AND ENERGY
NO. 1585 K/32/MPE/1999 ; DATED OCTOBER 13, 1999

RE

REQUIREMENTS FOR DOMESTIC MARKETING OF FUELS OF THE TYPES
OF GASOLINE AND DIESEL OIL

THE MINISTER OF MINES AND ENERGY,

- Considering : a. that in the framework of fulfilling the demand of the mechanical technology and the stage of the blue sky program implementation as well as anticipating the era of the liberalized trade, it is necessary to regulate the requirements for domestic marketing of fuels of the types of gasoline and diesel oil in fulfillment of the said demand;
b. that in connection with the matter referred to in letter a above, it is deemed necessary to stipulate the requirements for domestic marketing of fuels of the types of gasoline and diesel oil in a decree of the Minister of Mines and Energy.

- Bearing in mind : 1. Act No. 44 Prp/1960 (State Gazette No. 133 of 1960, Supplement to State Gazette No. 2070);
2. Act No. 8 of 1971 (State Gazette No. 76 of 1971, Supplement to State Gazette No. 2971);
3. Presidential Decree No. 122/M/1998 dated May 22, 1998;
4. Decree of the Minister of Mines and Energy No. 0223 K/43/M.PE /1991 dated February 13, 1991;

HAS DECIDED :

- To stipulate :
FIRSTLY : It shall be obligatory that every fuel of the type of gasoline and diesel oil which shall be marketed domestically shall take into account the development of mechanical performance and technology and shall have to be environmentally friendly.
SECONDLY : Specifically with respect to fuel oil of the type of gasoline in the form of Premium and Premix as meant in the First Dictum, it shall be obligatory that the requirement that they shall contain no lead or lead compounds should be fulfilled.

- THIRDLY** : The implementation of the provisions as meant in the First and Second Dictums shall take place in stages in accordance with the capacity of the domestic oil refineries and these provisions shall, by way of obligation, have to be fully implemented at the latest on January 1, 2000.
- FOURTHLY** : Further implementation of this Ministerial Decree, including the stipulation of the specification of fuels of the types of gasoline and diesel oil shall be regulated by the Director General of Natural Oil and Gas.
- FIFTHLY** : This Ministerial Decree shall take effect as from the date of stipulation.

**AMENDMENT TO PRESIDENTIAL DECREE NO. 61 OF 1988 ON THE STATUS, TASKS,
ORGANISATIONAL STRUCTURES AND OPERATIONAL PROCEDURES OF MINISTRIES
AS ALREADY SEVERAL TIMES AMENDED, THE LATEST BY PRESIDENTIAL
DECREE NO. 144 OF 1998**

THE PRESIDENT OF THE REPUBLIC OF INDONESIA,

- Considering : that with a view to supporting the smooth implementation of the tasks of the Cabinet of Development Reforms established by Presidential Decree No. 122/M/1998 and further enhancing coordination, integration and synchronisation in the execution of tasks of Ministers heading Ministries under the ever increasing progress of development in all sectors, it is deemed necessary to improve Presidential Decree No. 61 of 1998 on the status, tasks, organisational structures and operational procedures of ministries, as already several times amended tyhe latest by Presidential Decree No. 192 of 1998.

- Bearing in mind** :
1. Article 4 paragraph (1) of the Constitution of 1945;
 2. Presidential Decree No. 61 of 1998 on the status, tasks, organisational structures and operational procedures of ministries as already several times amended, the latest by Presidential Decree No. 144 of 1998.

H A S D E C I D E D :

To stipulate : **THE PRESIDENTIAL DECREE CONCERNING AMENDMENT TO PRESIDENTIAL DECREE NO. 61 OF 1988 ON THE STATUS, TASKS, ORGANISATIONAL STRUCTURES AND OPERATIONAL PROCEDURES OF MINISTRIES AS ALREADY SEVERAL TIMES AMENDED, THE LATEST BY PRESIDENTIAL DECREE NO. 144 OF 1998.**

Article I

To amend the provision in Article 109 of Presidential Decree No. 61 of 1998 on the status, tasks, organisational structures and operational procedures of ministries as already several times amended the latest by Presidential Decree No. 144 of 1988, so that it reads entirely as follows :

"Article 109

The Ministry of Forestry and Plantations shall be composed of :

1. The Minister of Forestry and Plantations.
2. The Secretariat General.
3. The Inspectorate General.
4. The Directorate General of Land Rehabilitation and Social Forestation.
5. The Directorate General of Nature Protection and Conservation.
6. The Directorate General of Production Forest Exploitation.
7. The Directorate General of Plantations.
8. The Agency for Forestry and Plantation Planning.
9. The Agency for Forestry and Plantation Research and Development.
10. Centres.
11. Vertical agencies in regions.

Article II

This presidential decree shall come into force as from the date of stipulation.
