

**ANNULMENT OF PESTICIDE REGISTRATIONS AND LICENSES**  
(Decree of Minister of Agriculture No. 221/Kpts/SR.140/4/2004 dated April 13, 2004)

MINISTER OF AGRICULTURE,

Considering:

- a. that, some holders of certificates of registration of pesticide formulas have submitted a request to annul their pesticide registrations and licenses;
- b. that, some of the formulas have been replaced with similar ones;
- c. that, based on the matter as mentioned above, it is necessary to annul the registration certificates and licenses as meant in paragraphs a and b.

D E C I D E S :

To stipulate:

DECREE OF THE MINISTER OF AGRICULTURE ON ANNULMENT OF PESTICIDE REGISTRATIONS AND LICENSES.

Article 1

- (1) To annul registration certificates and licenses of pesticides.
- (2) Pesticides, as mentioned in paragraph (1) shall not be imported and/or manufactured locally.

Article 2

Pesticides, as mentioned in Article 1, which have been imported and/or manufactured locally prior to the stipulation of this Decree, may be circulated and utilized in accordance with the applicable rulings within a period of no more than one (1) year since the stipulation of this Decree.

Article 3

If the pesticides as mentioned in Article 1 have not been used up within the period as mentioned in Article 2, those must be exited from the Indonesian territory or destroyed by the owners or the controlling party in accordance with the applicable regulations.

Article 4

This Decree shall come into effect from the date of stipulation.
